Zilker Zephyr: History, Operations & Improvements

- October 1996- Contract inception.
- Winter 2014- Concessionaire financed, designed and constructed a small retaining wall to contain erosion.
- August 2017- Concessionaire completed ADA improvements: train car, ticket booth, ramp with handrails.
- October 2018- Ticket price increased by \$1 (discounts for active military, seniors, public schools, special needs groups).




Zilker Zephyr: Contract & Revenue History

Estimated repair cost: \$286,000, 14-month timeline. Repair cost is the responsibility of the vendor per the current contract.

Zilker Park Master Plan development in progress


Contributing Factors Explained:

- Barton Springs Master Plan concession assessments recommended changes.
- A future Zilker Park Master Plan could have additional recommendations with substantive changes to current Zilker Park concessions.
- Delaying solicitation allows Zilker Park Master Plan to be adopted.
- Force Majeure event invokes contractor to suspend services.
- Establishment of a professional services contract would allow the vendor to recoup track repair cost.

Professional Services Contract Benefits



- The proposed professional services contract would:
 - Allow TEXAS SPECIAL, INC. to continue providing the iconic Miniature Train Concession to Zilker Park patrons for five additional years
 - o Four-year initial term with
 - 1 one-year extension
 - Provide sufficient time for the current vendor to recoup the \$286,000 repair resulting from the May 2019, storm damage

Requested Board Action

Staff Recommendation:

Recommend to the PARD Director to authorize the negotiation and execution of a professional services contract allowing Texas Special Inc. to continue providing the miniature train concession at Zilker Park for a five-year period.
