CALL TO ORDER

The meeting was called to order at 6:45 PM

1. CITIZEN COMMUNICATION: GENERAL

The first ten speakers signed up prior to the meeting being called to order will each be allowed a three-minute allotment to address their concerns regarding items not posted on the agenda.

No citizens signed up to speak.

2. APPROVAL OF MINUTES - July 10, 2019

Minor changes to the minutes were read into the record.

Motion to approve minutes as amended made by Chair Pitts, seconded by Commissioner DasGupta passed on a vote of 9-0.

 - a. Presentation of police video coordination with Travis County Prosecutor's Office (Troy Gay, Assistant Chief of Police, City of Austin)

b. Presentation on the re-design of the City website (Yasmin Wagner, Manager, City of Austin)

There was no presentation on this item.

4. NEW BUSINESS (Discussion and Possible Action)

a. Introduction of new Commissioner (appointed by Mayor Steve Adler)

Commissioner Sophie Gairo introduced herself to the Commission.

b. Recommendations for the 2020 Grant for Technology Opportunities Program (Jesse Rodriguez, City of Austin)

John Speirs and Jesse Rodriguez gave an overview of the changes to the GTOPs 2020 cycle, including how the increase in funding of \$200,000 will be utilized. The memo supporting this presentation can be viewed here.

Motion to approve the recommendations made for the GTOPs 2020 process made by Commissioner DasGupta, seconded by Commissioner Floyd passed on a vote of 9-0.

c. Update on the Land Development Code Revision Team Resolution and possible action proposing a Council Committee Agenda Request

Motion to approve the Council Committee Agenda Item Request made by Commissioner Yeatts and seconded by Commissioner DasGupta passed on a vote of 9-0.

5. COMMISSION UPDATES (Discussion and Possible Action)

a. Digital Inclusion and Civic Engagement Working Group

Chair Pitts noted the success of the Commission in doubling the funding of GTOPs and a community meeting on planning for the coming Digital Inclusion Week (October 7-11). He also mentioned scheduling a joint working group call with this working group, the Strategic Technology and Telecom Policy Impact Working Group, and HACA.

b. Knowledge, Information, and Data Stewardship Working Group

Commissioner Alexander noted that this working group is keeping tabs on the update to the City Website and will track the progress of the Council Committee Agenda Request passed under item 4c. He is interested in finding out how to enhance transparency and collaboration in the City and between the City and the County.

c. Technology, Infrastructure, and Innovation Working Group

Commissioner DasGupta noted that the working group has generated a list of questions for San Antonio's energy authority on the topic of One Touch Make Ready. They will send the list of questions to San Antonio a week ahead of the call, once scheduled.

d. Strategic Technology and Telecom Policy Impact Working Group

Commissioner Ayman noted that the Working Group had narrowed down the time frame of the proposed summit to either SXSW (April-March) or Digital Inclusion Week (October) in 2020. She also discussed possibly partnering with the Austin Forum on Technology and Society and Society of Information Management. Chair Pitts noted that the group would be reaching out to the County Commissioners, CTM CIO Stephen Elkins, as well as key contacts at Austin Energy, Austin Water, and Capital Metro. Chair Pitts advocated towards holding the summit during Digital Inclusion Week 2020
