Authorize the execution of an interlocal agreement with the City of Round Rock concerning the capacity, operation, maintenance, and capital improvement to the Lake Creek Collection System. (District 6)

The Brushy Creek Regional Wastewater System ("BCRWWS") is a wastewater system located in southern Williamson County. The cities of Austin, Round Rock, and Cedar Park jointly purchased, in 2009, the BCRWWS from the Lower Colorado River Authority and each city is a customer of BCRWWS. The City of Leander joined the other cities as a partial owner in 2011. The City of Round Rock operates and maintains the Brushy Creek System for the cities. Austin has approximately 4,800 retail wastewater connections, all located within the Desired Development Zone, and which discharge into the Brushy Creek System (most connections are currently located within the Avery Ranch subdivision).

Austin and Round Rock entered into an Agreement for Capacity, Operation, Maintenance, and Capital Improvements to the Lake Creek Collection System that set forth the terms for a shared collection system as a component of the BCRWWS. The shared collection system between Austin and Round Rock consists of the South Interceptor, the Southwest Interceptor, and the Lake Creek Interceptor (collectively the "Lake Creek Collection System"). In the original Agreement, the Southwest Interceptor terminated at Node 45001 (a 12-inch wastewater main connection along FM 1325). The line upstream of Node 45001 was a Round Rock only line that was not considered a part of the Lake Creek Collection System. Now Austin wishes to include approximately 2,200 linear feet of line beginning at Node 45001 to Node 34001F as an extension of the Southwest Interceptor to provide for future development.

Capital costs for the 2,200 linear feet of line will be passed on to the developer and Austin will collect all standard retail fees and charges, including capital recovery fees.
