

## **MBE/WBE Summary**

Public notice was given for this solicitation CLMC745 Walnut Creek Wastewater Treatment Plant Sludge Thickener Rehabilitation through the City's Vendor Connection web portal. Four bids were received and opened on August 8, 2019. Of the four bids received, none of the firms submitting were certified MBE/WBE. PLW Waterworks, LLC submitted the lowest responsive bid of four bids received including allowances of \$150,000:
