What are Boards & Commissions?

- A board or commission is a group of people appointed to help the Council make sound decisions and shape or influence policy.
- There are two kinds of Boards:
 - Advisory Boards
 - Sovereign Boards

Advisory Boards

- Make recommendations to Council.
- Tasked with taking on issues and concerns of citizens, understanding and exploring possible options & providing feedback and recommendations to Council.
- Make Council Committee Agenda Requests to Council.

- Exercise independent authority and make decisions.
- Established by federal law, state law or City Charter.

Why have Boards & Commissions?

- Board activities help shape or influence policy in many ways.
- Offers citizens an opportunity to participate in the City's governmental affairs.
- Balances public interests in order to make informed recommendations to Council.
- They help Council get a more comprehensive understanding of what is at stake, and where the balance should be struck.

Board Recommendations

- Used to communicate with Council details, explanations and rationale for a decision on a significant issue
- Concerns an item or topic <u>currently</u> on a Council agenda or Council Committee agenda.
- Used to express a BC's support or lack of support for an item being discussed by Council.
- Must be approved at a BC Meeting as an item on the agenda.

Board Recommendations

- Use the standard template provided by the City Clerk's Office.
- Upload to the Board and Commission Information Center (BCIC) and can be found in Meeting Documents under the meeting in which it was approved.
- Processed twice a day (Monday Friday) at 10am & 3pm
- Automatically generates an email to all of Mayor and Council.

Council Committee Agenda Request

- Used to communicate with Council details and a request to have an item or topic placed on a future Council Committee agenda for discussion.
- Used to submit a new item for Council discussion not currently included on a Council Committee agenda, Council Work Session agenda or a regular Council Meeting agenda.

Council Committee Agenda Request

- Must be approved at a BC Meeting as an item on the agenda.
- Use the standard form provided by City Clerk's Office.
- Uploaded to the BCIC and can be found in Meeting Documents under the meeting in which it was approved.
- Processed twice a day (Monday Friday) at 10am & 3pm
- Automatically generates an email to Mayor & Council.
- Mayor will review and refer it to the appropriate Council Committee or Committees and notify the appropriate Council Chair(s).
