- Study conducted on affordable housing in 78702 zip code
 - Identified gap in affordable housing serving 20-80% MFI
 - Follow-up study to survey residents of density bonus developer program
- Overview of Green and Healthy Home Initiative Program
 - Central East Austin is most highly served geographic area with an average resident age of 57
 - Most common issues include electrical systems, exterior structure, ventilation, pest control, stair condition and moisture control
- b) Land Development Code –, Austin Transportation Department (Discussion and/or possible action) 45 minutes
 - Land Development Code rewrite draft released on October 4th
 - Follows May 2nd council guidance on scope, housing capacity, missing middle housing, compatibility and parking
