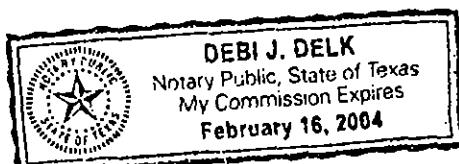

ORDINANCE NO. 040108-16
AN ORDINANCE AMENDING SECTION 12-4-23 OF THE CITY CODE TO REPEAL THE SUBSECTION RELATING TO HIGHVIEW DRIVE AND TO ADD PORTIONS OF SPRING LAKE DRIVE / HIGHVIEW DRIVE, GLASS MOUNTAIN TRAIL, AND ASHARA DRIVE / HIGH HOLLOW DRIVE TO THE LIST OF STREETS HAVING A MAXIMUM SPEED LIMIT OF 25 MILES PER HOUR; AMENDING SECTION 12-4-41 OF THE CITY CODE TO ADD A PORTION OF RIVER PLACE BOULEVARD TO THE LIST OF STREETS HAVING A MAXIMUM SPEED LIMIT OF 35 MILES PER HOUR; AND AMENDING SECTION 12-4-43 OF THE CITY CODE TO ADD PORTIONS OF MCNEIL DRIVE AND RIVER PLACE BOULEVARD TO THE LIST OF STREETS HAVING A MAXIMUM SPEED LIMIT OF 45 MILES PER HOUR.
