4. CITIZENS COMMUNICATION (90 minutes)

Citizens Communications is an opportunity to share feedback on how the bond funds will best reflect the community values and needs - not to pitch specific organizations, existing real estate or entities. (Please provide input at www.speakupaustin.org/bond-for-creative-space to share those ideas.)

- a. Eric Radford, hip-hop and R&B musician, encourages Commissioners to think about marginalized people.
- b. Nathalie Phan, EQ Austin music nonprofit, recommends putting money into music hub, into Mosaic or building a hub, or putting money into the Carver.
- c. Anna Maciel, President of Cantu Pan American Rec Center, recommends expanding and rebuilding existing spaces like the PanAm Rec Center.
- d. Johnny Limon supports money for the MACC which is a hub of our community.
- e. Candyce Rusk, playwright, explains the difficulty in finding rehearsal space.
- f. Gabriela Kane, Texas Folklife, asks to keep in mind accessibility and consider parking; would like to see improved partnerships between businesses, especially for parking.
- g. Dan Redman, Mosaic Sound Collective, supports the recommendations to Council.
- h. Monique Dacheff supports funding productions instead of venues. Venue costs have been \$10-\$15k per night.
- i. Charlene Franz, Museum Fine Arts Austin, holding a Van Gogh exhibit in January. Would like own space in the future. Would like City support.
- j. Tyson Swindell, Red River Cultural District (RRDC) and Mohawk, many venues in the district will rent affordable space during the day.
- k. Eddie Stout, East Side Kings Foundation and Dial Tone Records, increasingly loses venue space for festival each year. Spaces are disappearing.
- 1. Paul Deemer, educator and touring musician, needs space for classes and to teach music business acumen, artist development, and money management.
- m. Larry Amaro wants funds to support Mexican-American community, the MACC expansion, Pan AM Hillside Theatre, Zaragosa Recreation Center.
- n. Pat Buchta, Executive Director of Austin Texas Musicians supports funding multiple existing spaces, like Mosaic Sound Collective and MACC, and equitable solutions for entire music community.
