Call to Order: The meeting was called to order at 6:05 p.m. by Chair Adam Greenfield.

- 1. Approval of September – November 2019 meeting minutes:** The [September](#), [October](#), and [November](#) 2019 meeting minutes were approved on a 6-0 vote with Mulcahy, Henderson and Armstrong absent.
- 2. Traffic Fatalities Reported Since November 2019 PAC Meeting:** Kimberly Levinson read aloud the names and ages of people whose deaths due to traffic crashes on Austin streets were reported since the PAC last met as well as the locations at which the crashes occurred.
- 3. Draft 2020 Mobility Annual Plan:** A [presentation](#) was made by Laura Dierenfield, Austin Transportation Active Transportation and Street Design Division Manager.
- 4. Mobility Project Database development:** A [presentation](#) was made by Amenity Applewhite and John Clary of the Austin Transportation Data and Technology Services Division.
- 5. Consideration of a PAC recommendation requesting regular updates on City of Austin implementation of pedestrian infrastructure:** Greenfield proposed recommendation language which, after discussion and amendment, read as follows:

NOW, THEREFORE, BE IT RESOLVED, the PAC supports giving a high prioritization to the swift development and completion of the MPD, which will provide a new standard of information to the public, allowing a new level of transparency and helping to stoke public support for more and higher quality pedestrian infrastructure;

BE IT ALSO RESOLVED, the PAC recommends that, using the MPD and other available sources, the City of Austin increase public updates, through social media and other platforms, about all recently completed pedestrian infrastructure projects, such updates appropriately tagged for findability and sortability, geographically locatable, and including photos taken before and after such projects were completed.

The [recommendation](#) was approved on a 6-0 vote with Mulcahy, Henderson and Armstrong absent.

- 6. Updates + Announcements:** PAC Chair Adam Greenfield celebrated the [recent rollout](#) of several leading pedestrian intervals (LPIs) in downtown Austin.
