- 1. Approval of previous meeting minutes:** The [June 2020 PAC meeting minutes](#) were approved on a 6-0 vote with Bauereis, Henderson and Wochner absent.
- 2. Traffic fatalities reported since June PAC meeting:** Kimberly Levinson read aloud the names and ages of people whose deaths due to traffic crashes on Austin streets were reported since the PAC last met as well as the locations at which the crashes occurred.
- 3. I-35 Capital Express Program:** Susan Fraser, Texas Department of Transportation Capital Area Mobility35 Program Manager, gave a [presentation](#) regarding the [I-35 Capital Express Program](#), including Mobility35 Program goals and objectives, shared-use paths within Mobility35 projects, I-35 Capital Express Central funding status, I-35 Capital Express Central Project public engagement timeline and Mobility35 Shared-Use Path, Striping, Signage and Design Treatments Guidance.

Street Impact Fee Study results and draft policy recommendation:** Liane Miller, Austin Transportation Program Manager, gave a [presentation](#) regarding [Street Impact Fee](#) study results and draft policy recommendations, including work to date, prior actions, Maximum Impact Fee recommendation, Draft Policy recommendation, community feedback and next steps.

  - Jay Crossley: encouraged meeting attendees to check out an upcoming [Farm&City webinar](#) regarding transportation equity and justice reform in Texas on August 6.
