- 8. Recommendation regarding Redbud Trail Bridge:** Curtis Rogers introduced a draft recommendation which, after deliberation and amendment, read as follows:

NOW, THEREFORE, BE IT RESOLVED, the BAC recommends the Public Works Department study the potential of including an auto toll on the new Redbud Trail Bridge. Some considerations include, but are not limited to:

- Adjusted rates for rush hour.*

○ *Congestion pricing is a proven, viable, and effective tool. Charging a fee for the parts of the roadway network used the most during the busiest times of day reduces demand. The charges incentivize travelers to switch to other modes of transportation, seek alternative routes, or travel at other times. The charges can help to reduce negative effects of traffic such as air pollution, carbon emissions, road damage, and traffic crashes. - *Lower rates for residents of cities listed as funding sources for the bridge.*
- *Locating the toll on the west side of the bridge.*
