





MASTER PLAN - PHASE ONE



PHASE ONE

- 1 Demolish and relocate existing parking lot
- 2 Enlarge event lawn
- 3 Create accessible, shaded pathways into park
- 4 Provide seating, lighting, and site furnishings
- 5 Protect Heritage trees

MASTER PLAN - PHASE TWO



PHASE TWO

- 1 Remove parking lot
- 2 Demolish Fire Station annex and create north entrance to park
- 3 Renovate Fire Station for public use
- 4 Expand lawn and performance area
- 5 Complete Great Streets






- Great Streets/Subchapter E Conflict area
- Meets Great Streets/Subchapter E criteria
- Heritage Tree 50% Critical Root Zone
- Proposed Limit of Work

“The plan applies Great Streets principles to all available street edges where sufficient space exists. Large portions of the street edge remain unavailable for public use in Phase 1 owing to the continued operations of the fire station. The right of way of Neches Street is seriously constrained by the turn-around lane to be constructed as part of the CapMetro Downtown Station project but this face of the Square also received additional street trees where possible.”
