THIS MEETING IS LIMITED IN DURATION. PLEASE MAKE PRESENTATIONS AS BRIEF AS POSSIBLE (Consider 7-8 minutes) SO THAT ALL APPLICANTS MAY HAVE THE CHANCE TO PRESENT TO AND RECEIVE INPUT FROM THE COMMITTEE MEMBERS.

Community members will be allowed to listen to the meeting via telephone but do not participate in the meeting. This is a virtual meeting; no in-person input will be allowed. The opportunity for public input will occur at a subsequent meeting of the Historic Landmark Commission. **All participants (applicants and others) must register in advance (no later than 12:00 noon on Sunday, October 11, 2020 to be notified of the call-in number and other instructions).**

To listen to the Architectural Review Committee meeting, community members must:

- Applicants will be placed in a queue until their time to speak.
