## ORDINANCE NO.

# AN ORDINANCE AMENDING THE FY 2003-2004 POLICE DEPARTMENT OPERATING BUDGET OF ORDINANCE NO. 030909-01 TO INCREASE APPROPRIATIONS AND DECREASE THE GENERAL FUND ENDING BALANCE; AND DECLARING AN EMERGENCY.

# BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

**PART 1.** The Council amends the Fiscal Year 2003-2004 Operating Budget of Ordinance No. 030909-1 to appropriate \$1,300,000 to the Austin Police Department for public safety equipment and to reduce the General Fund Ending Balance by the same amount.

**PART 2.** The Council finds that the need to amend the budget constitutes an emergency, a grave public necessity, and an unusual and unforeseen condition that could not, by reasonable diligence, have been included in the original budget for the current fiscal year. Because of this emergency, this ordinance takes effect immediately on its passage for the immediate preservation of the public peace, health, and safety.
