ORDINANCE NO. 20201117-002

AN ORDINANCE ORDERING A RUNOFF ELECTION TO BE HELD IN THE CITY OF AUSTIN ON DECEMBER 15, 2020, FOR THE PURPOSE OF ELECTING CITY COUNCIL MEMBERS (SINGLE MEMBER DISTRICTS) FOR DISTRICT 6 AND DISTRICT 10; MAKING PROVISION FOR THE CONDUCT OF THE ELECTION; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. A municipal runoff election shall be held in the City of Austin on December 15, 2020, in accordance with the provisions of Article II and Article III of the Austin City Charter and the laws of the State of Texas. At the election there shall be elected by majority vote of the qualified voters of District 6 a City Council Member for District 6 and by majority vote of the qualified voters of District 10 a City Council Member for District 10. The candidates for District 6 shall meet all requirements and shall be residents of District 6, and the candidates for District 10 shall meet all requirements and shall be residents of District 10.

PART 2. The election shall be conducted between the hours of 7:00 a.m. and 7:00 p.m. The location of the main early voting polling place, the dates and hours for early voting, and the early voting clerk's official mailing address; the precincts and locations of the election day polling places; the dates, hours, and locations of the early voting places; and the names of the officers appointed to conduct the election are provided in Exhibits A-F attached and incorporated as a part of this ordinance.

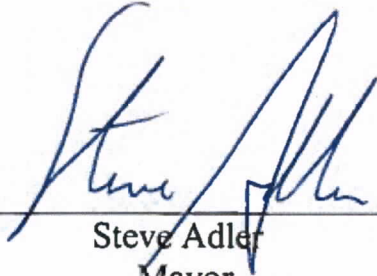
PART 3. A direct recording electronic voting system, as the term is defined in Title 8 of the Texas Election Code, shall be used for early voting and for voting conducted on election day. The central counting station is established at the Travis County Elections Division, 5501 Airport Boulevard, Austin, Texas.

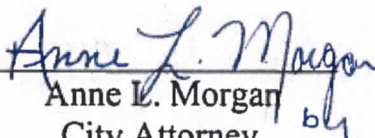
PART 4. Notice of this election shall be given by posting and publishing a copy of this ordinance in both English and Spanish. The notice and a copy of this ordinance shall be posted, in both English and Spanish, in the office of the City Clerk and at the City Hall notice kiosk not later than the 15th day before election day. Notice of this election shall be published one time, not earlier than the 30th day before the date of the election or later than the 10th day before the date of the election, in a newspaper of general circulation in the City of Austin.

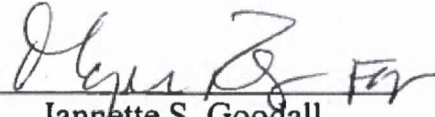
PART 5. The candidates elected at the November 3, 2020 general election and the December 15, 2020 runoff election shall take the oath of office on January 6, 2021, and begin their tenure once qualified.

PART 6. The Council finds that, because of the curtailed period for a runoff election and the desire of the Council to provide an opportunity for early voting, there is a need to immediately begin required preparations for this election. Such need constitutes an emergency, and the Council declares that an emergency exists. Because of this emergency, this ordinance takes effect immediately on its passage for the immediate preservation of the public health, safety, and general welfare.

ORDENANZA NO. 20201117-002

ORDENANZA PARA CONVOCAR UNA ELECCIÓN SECUNDARIA QUE SE EFECTÚE EN LA CIUDAD DE AUSTIN EL 15 DE DICIEMBRE, 2020 CON EL PROPÓSITO DE ELEGIR CONCEJALES (EN DISTRITOS UNI-MIEMBRO) PARA EL DISTRITO 6 y DISTRITO 10; PARA DISPONER PROVISIONES TOCANTES LA ADMINISTRACIÓN DE LA ELECCIÓN; Y PARA DECLARAR QUE HAY UNA EMERGENCIA.

POR ORDEN DEL CONSEJO DE LA CIUDAD DE AUSTIN:

PARTE 1. Una elección secundaria municipal se llevará a cabo en la Ciudad de Austin el 15 de diciembre, 2020 de acuerdo con disposiciones del Artículo II y el Artículo III de la Carta de la Ciudad de Austin, y de las leyes del Estado de Texas. En la elección, la mayoría de los votantes calificados del Distrito 6 elegirán al concejal de la Ciudad para el Distrito 6; la mayoría de los votantes calificados del Distrito 10 elegirán al concejal de la Ciudad para el Distrito 10. Los candidatos para el puesto del Distrito 6 cumplirán todos los requisitos y serán residentes del Distrito 6; los candidatos para el puesto del Distrito 10 cumplirán todos los requisitos y serán residentes del Distrito 10.

PARTE 2. La elección se efectuará durante las horas de las 7:00 a. m. a las 7:00 p.m. La ubicación del sitio principal de la votación adelantada; las fechas y horas de la votación adelantada, la dirección postal oficial de la secretaria de la votación adelantada; los precintos y ubicaciones de los sitios de votación el día de la elección; las fechas, horas y sitios de la votación adelantada; y los nombres de los oficiales nombrados para efectuar la elección se indican en los Adjuntos A-F adjuntados e incorporados como parte de esta ordenanza.

PARTE 3. Un "sistema electrónico de votación directa" de acuerdo con el término definido en el Título 8 del Código Electoral de Texas, se usará en la votación adelantada y en la votación efectuada el día de elección. La Estación Central Para Contar Votos se ubicará en la División de Elecciones del Condado Travis en 5501 Airport Boulevard, Austin, Texas.

PARTE 4. El aviso de esta elección se hará fijando y publicando una copia de esta Ordenanza en ambos idiomas, inglés y español. El aviso y una copia de esta ordenanza se fijarán, en ambos idiomas, inglés y español en la oficina de la Secretaria de la Ciudad y en el kiosco de avisos en el Edificio Municipal (City Hall), a no más tardar del 15vo día antes del día de la elección. El aviso de esta elección será publicado una vez, en fecha que no sea anterior del 30vo día de la fecha de la elección ni más tardar del 10mo día antes de la fecha de la elección, en un periódico de circulación general en la Ciudad de Austin.

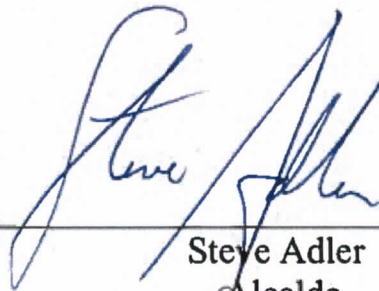
PARTE 5. Los candidatos electos el 3 de noviembre, 2020, en la elección general y en el 15 de diciembre, 2020, en la elección secundaria, tomarán el juramento del puesto y principiarán sus plazos en el puesto el 6 de enero, 2021.

PARTE 6. El Consejo determina, que por ser corto el tiempo para efectuar la elección secundaria, y como el Consejo desea dar oportunidad para la votación adelantada, hay la necesidad de iniciar inmediatamente los preparativos requeridos para esta elección. Dicha necesidad constituye una emergencia, y el Consejo declara que existe la emergencia. Por haber esta emergencia, esta ordenanza tendrá vigor inmediatamente al aprobarse para la conservación inmediata del orden público, la salud, seguridad, y bienestar en general.
