- 16 plaque is placed.
- 17 (B) A facility may be named for an individual, living, or dead, or something other than an individual. A

- 30 (A) A person may submit a suggestion for naming a facility or endorse a previously submitted

112 City and dedicated or used for park purposes. Significant building includes recreation, senior, cultural

- 119 § 14-1-37 PARK NAMING POLICY.
- 120 (A) Subject to a valid agreement governing the naming of a park facility or park feature, a park feature
- 121 <u>with</u>in a park facility may be dedicated to an individual or group to recognize a culturally significant
- 122 contribution, other valuable contribution, or creditable service to the park system or the community
- 123 without naming or renaming the park facility in which the feature is located. A plaque recognizing a
- deserving individual or group may be placed by the park feature without naming or renaming the park
- facility in which the plaque is placed. Additional plaques recognizing other individuals or groups may be
- 126 placed at the same feature location. Each plaque may be removed only when the park feature is

- (C) A non-refundable application fee must be paid at the time of submission of the application fornaming or renaming a feature or facility.
- (D) If a name is approved by council or the director, a sign fabrication, plaque and installation fee mustbe paid prior to fabrication.
