<u>AMOUNT & SOURCE OF FUNDING</u>: Funding in the amount of \$2,650,000 is available in the Fiscal Year 2003-2005 Approved Capital Budgets and/or Operating Budget of the Public Works Department and various other department for which services are needed.

**<u>PURCHASING</u>**: Best eighteen qualification statements of twenty-eight received.

MBE / WBE: Participation goals stated in the solicitation were 5.47% MBE and 3.05% WBE.

October 26, 2000, eighteen consultants firms were selected for the Surveying Services Rotation List 2000-2003. The total authorization amount at that time was \$2,250,000. This Surveying Services Rotation List 2003-2005 replaces the existing rotation list for 2000-2003, which has exhausted its authorization.

The selected firms will provide all surveying services to the City of Austin for field surveying and associated office services for projects design, boundary determinations, acquisition of easements and related documentation. Projects will be assigned to firms on the basis of qualifications and ability to respond within the required time frame.

This authorization provides for funding of surveying services for approximately \$2,650,000., (estimated approximately \$175,000 for each of the top eight ranked firms and \$125,000 for each of the next ten top

ranked firms). The period of services is estimated to be approximately two years or until financial authorization is expended.

This request allows for the development of a professional services agreement with each of the eighteen firms recommended for this Surveying Services Rotation List. This rotation list will allow assignment of projects based on the firms' availability of resources and expertise. Should the City be unsuccessful in negotiating a satisfactory agreement with any of the recommended firms, negotiations will cease with that firm and the funding will be distributed among the remaining firms.

Notification of issuance of a Request for Qualifications (RFQ) for the subject services was sent to seventyone firms on September 11, 2003. The RFQ was obtained by forty-four firms, and twenty-eight firms submitted qualification statements. Ten of the firms were certified Minority/Women-Owned Business Enterprise (M/WBE) firms. The evaluation of the submittals of the twenty-eight firms results in the following recommendation.

Participation goals stated in the solicitation were 5.47% MBE and 3.05% WBE. The recommended firms provided M/WBE Compliance Plans, which were approved by the Department of Small and Minority Business Resources.
