**SUBJECT:** Authorize execution of a 12-month service agreement with DIAMOND DETECTIVE AGENCY, INC., Chicago, IL for security guard services in an amount not to exceed \$107,134.80, with two 12-month extension options in an amount not to exceed \$107,134.80 per extension option, for a total agreement amount not to exceed \$321,404.40.

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$44,639.50 is available in the Fiscal Year 2003-2004 Approved Operating Budget of the Austin Water Utility Department. Funding for the remaining seven months of the original contract period and extension options is contingent upon available funding in future budgets.

This contract will establish a 12-month service agreement for security guard services at the Austin Water Utility. The contract will provide for unarmed guards to monitor and secure City property, 24-hours per day, seven days at week, at Waller Creek Plaza, 625 East 10th Street.

All services provided would be in accordance with the provisions of the PRIVATE INVESTIGATORS and PRIVATE SECURITY AGENCIES ACT ARTICLE 4413(29bb) V.A.C.S. The Contractor will conduct a criminal history check on each security guard. No security guard will be allowed to provide service until the certification has been reviewed and approved by the Contract Administrator or designee. Furthermore, periodic background investigations shall be conducted and documented by the Contractor to verify that each security officer continues to meet the qualifications.
