SUBJECT: Authorize execution of a 12-month supply agreement with LONE STAR READY MIX (WBE/FH), Austin, TX and CEMEX CONSTRUCTION MATERIALS, Austin, TX for ready mix concrete for the Public Works Department in an amount not to exceed \$140,930, with two 12-month extension options in an amount not to exceed \$140,930 per extension option, for a total contract amount not to exceed \$422,790.

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$82,209 is available in Fiscal Year 2003-2004 Approved Operating Budget of the Public Works Department. Funding for the remaining five months of the original contract period and the extension options is contingent upon available funding in future budgets.

MBE / WBE: This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

This supply agreement will provide for ready mix concrete to be used by the Public Works Department / Street and Bridge Division for street maintenance and construction activities.

The ready mix concrete is used by the Street and Bridge Division for concrete pavement repairs, concrete utility cut repairs, sidewalk construction, American Disability Act (ADA) ramp construction requirements, curb and gutter construction. driveway construction and bus stop pad construction.

The bid was structured for award to both a primary contractor (first low bidder) and alternate contractor (second low bidder) to assure the City of a reliable supply of ready mix concrete. The need for an alternate supplier is to address the times when Lone Star Ready Mix, the primary contractor, has large orders from other customers that deplete all of its ready mix and may not be able to fulfill the City's needs.
