4. APPROVAL OF MINUTES 🚩

Minutes were approved as written, unanimously

5. FISCAL YEAR 20 REALLOCATION 🚩

- a. Anthony Kitzmiller reviewed the reallocation of \$30,000 from Administration to Medical Case Management
 - i. Reallocations were approved, unanimously


6. PREXPOSURE PROPHYLAXIS (PrEP) STUDIES PRESENTATION

- a. Dr. Leisl Nydegger will update the Planning Council on her previous and current studies around PrEP, HIV, and sexual health
 - i. Dr. Nydegger reviewed her studies between PrEP intake and barriers that prevent people – specifically Black women – from getting it



1. Dr. Nydegger developed programs in response to responses from her studies, including home health, linkage to care, and support groups, and is hoping to secure grant funding

7. COMMITTEE UPDATES

- a. Governance/Membership Committee
 - i. Will be meeting on regular schedule
 - ii. Someone will be acting as chair during Akeshia's absence
 - iii. Membership Attendance update
 1. Committee will not be counting attendance against members at this time due to COVID-19
 - a. Office of support will reach out to members who have been absent for an extended time to update
 - iv. Ongoing discussion of social media activity and process of adding non-voting members to the committee
- b. Executive Committee
 - i. Nominations for Officers due by October 15, 2020
 1. Chairs give testimonies of their experiences and duties on Executive Community
- c. Strategic Planning/Needs Assessment Committee
 - i. Vote to end Minority AIDS Initiative (MAI) Directive 
 1. Glenn reported that all funds are expended and spent in a timely fashion, so the directive is no longer necessary
 2. Directive was voted to end, unanimously
 - ii. Working to form peer navigation and work with Care Strategies
- d. Care Strategies
 - i. Discussed the standards of care and how to go about updating unreviewed standards first
 1. Performance measures not providing impactful patientcare-related data
 2. Reviewing four most utilized service categories first
 3. Reaching out to other HIV Planning Councils in Texas to get ideas on how to proceed
 - ii. Exploring the letter of support or directive to ensure that ADAP is complying by payor of last resort
