**ELECTRONIC REGISTRATION FOR WRITTEN EXAMINATION:** As required by Civil Service Commission Rule 7.06, all eligible candidates who intend to take the examination <u>MUST</u> register.

**FINAL PROMOTIONAL ELIGIBILITY LIST:** The Director of Civil Service shall produce the eligibility list from which vacant positions shall be filled in rank order. The eligibility list shall rank all candidates based written examination score, together with any seniority points.

The exam is valid for 24 months from the date of the written exam. Pending appeals/disputes have no bearing on the effective date of the list.
