1. APPROVAL OF MINUTES

- a) October 28, 2020 meeting of the Joint Sustainability Committee
 - Motion to approve (Commissioner Schneider), second (Commissioner Hadden), 7 approved, 0 opposed, 1 abstained. Commissioner Davis was not yet on the dais.

2. NEW BUSINESS

- a) Government Relations Update—Brie Franco, Office of Intergovernmental Relations (Discussion and/or possible action)
 - Update provided on the bills filed so far in the Texas 87th Legislative Session
 - Some key issues include a new speaker being elected, Special Session on redistricting, school finance, budget, and COVID-19
 - Some city-related priority issues include super preemption, police reform, COVID-19, employees' rights, zoning, city lobbying, utility deregulation, revenue caps, and annexation.
 - Federal administration changes unlikely to have significant effects on state policy
- b) Presentation on Planet Texas 2050 initiatives—Dave Kramer, UT Austin (Discussion and/or possible action)
 - Planet Texas 2050 vision is that of a resilient Texas in the face of challenges from the climate crisis, growth and equity and justice issues
 - Overview of the Bridging Barriers initiatives, which was created to have a multi-year, interdisciplinary research program to address complex problems
 - Currently looking to apply lessons learned from year 1 & 2 and partnering with community organizations to advance justice and move from a community-informed to a community-directed approach
 - Focus areas include water quality, virtual reality and climate change, tropical diseases, and ongoing National Science Foundation-funded climate navigators project partnership with GAVA
- c) Update from the Climate Program Manager Zach Baumer, Office of Sustainability (Discussion and/or possible action)
 - The climate plan will be submitted as a Request for Council Action (RCA) from the Office of Sustainability
 - Office of Sustainability will be presenting to the Mobility and Housing and Planning Council Committees in early 2021, and will submit the item for consideration following these presentations
 - Discussion on ensuring alignment and collaboration with buildings codes process,
 Project Connect and Water Forward Can still proceed with implementation planning in the meantime
- d) Commission members report back on any relevant discussions from their respective boards and commissions (Discussion and/or possible action)
 - Planning Commission: focused on about housing, density and affordability, and will be thinking further about anti-displacement funding
 - Water and Wastewater Commission: focused on algae bloom, and examining the effects on resilience
 - Resource Management Commission: requested update on solar-ready code enforcement from Development Services Division, discussing how it can be enforced along with other aspects of the energy codes

• Austin-Travis County Food Policy Board: rethinking strategy, including alignment with other commissions on community engagement
