PURCHASING: Low bid of six bids received.

MBE / WBE: This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation. All work will be performed by the contractor's own workforce.

This contract will provide labor, material, equipment, installation and testing services necessary to replace ten existing 500 MVA circuit breakers and associated protective relays with ten 750 MVA replacement circuit breakers and associated protective relays. The larger equipment is necessary because larger transformers are being installed at the Summit Substation, which provides power for the equipment at the Domain Plant. Without the replacement equipment, the larger transformers would create a potential fault to ground current in excess of the current Domain Plant circuit breaker ratings.

Eight circuit breakers feed the Domain Plant that produces cooling, heating and compressed air for multiple tenants on the Domain Campus. Two circuit breakers feed directly to the IBM building 045 on that campus.
