SUBJECT: Authorize negotiation and execution of an agreement for the reimbursement of streetscape improvement costs to Merit Littlefield Mall, L.P. for the Littlefield Mall renovation project located at 115 East 6th Street under the Great Streets Development Program in an amount not to exceed \$104,670.

The Great Streets Development Program, a related item on this agenda, is a tool to aid emerging projects with the high cost of streetscape improvements that go above and beyond the City's minimum standards to achieve high-quality environments that aid downtown vitality. The Program establishes priorities and sets a maximum reimbursement (cap) based on criteria such as: location of development, proximity to transit, extends/leverages underground utility improvements or adjacent streetscape improvements, associated with a planned corridor, district or master plan, improves accessibility compliance, and other policy priorities. If a development project, as measured by the Development Program, advances the City's policy priorities, financial investments may be available to offset the higher cost of development in urban right-of-ways. This project is one of the first participants in the Program.

The Littlefield Mall Renovation project at 115 East 6th Street is located at the southwest corner of Brazos and 6th Street (See Exhibit A – Location Plan). The project consists of building and sidewalk renovations on a quarter-block opposite from the Driskill Hotel with enhanced streetscapes on East 6th and Brazos Streets consisting of 18-foot wide sidewalks, 5-inch caliper Street Trees, Great Streets lighting/traffic signal poles on Brazos Street and historic fixtures on East 6th Street, pedestrian amenities, on-street parking and special features including "Walk of Stars" sidewalk paving and a building-mounted Historic plaque. Great Streets Development Program Evaluation and Proposed Investments:

The project meets the Development Program criteria and earns the "HIGH" priority level for streetscape improvements. This "HIGH" priority status is used to establish a reimbursement cap of \$18 per square

foot applied to the enhanced sidewalk area. The Littlefield Mall Renovation project will provide 5815 square feet of improvements, bringing the reimbursement cap to \$104,670.

Terms of an Agreement between the City and Merit Littlefield Mall, L.P.:

Reimbursements require completion by Merit Littlefield Mall, L.P. of all design features as submitted to the City and reflected in the Great Streets Development Program. To ensure fulfillment of these commitments, staff recommends that incentives be approved conditioned upon the negotiation and execution of an agreement requiring the following:

- 1) Completion of streetscape improvements in compliance with TPSD-approved streetscape plans submitted under the Great Streets Development Program;
- 2) Completion of streetscape improvements in compliance with TPSD-approved license agreements submitted under the Great Streets Development Program, including tenant occupation of proposed café zone;
- 3) Participation in City's Minority & Women-Owned Business Enterprise Program through DSMBR.
- 4) Reimbursement funds are released by the City of Austin after final inspection and acceptance of improvements.

The requested action would authorize reimbursement for streetscape improvements not to exceed \$104,670, and authorize negotiation and execution of necessary agreements.

- Nearby Projects with Recent or Planned Streetscape Improvements (Labeled)

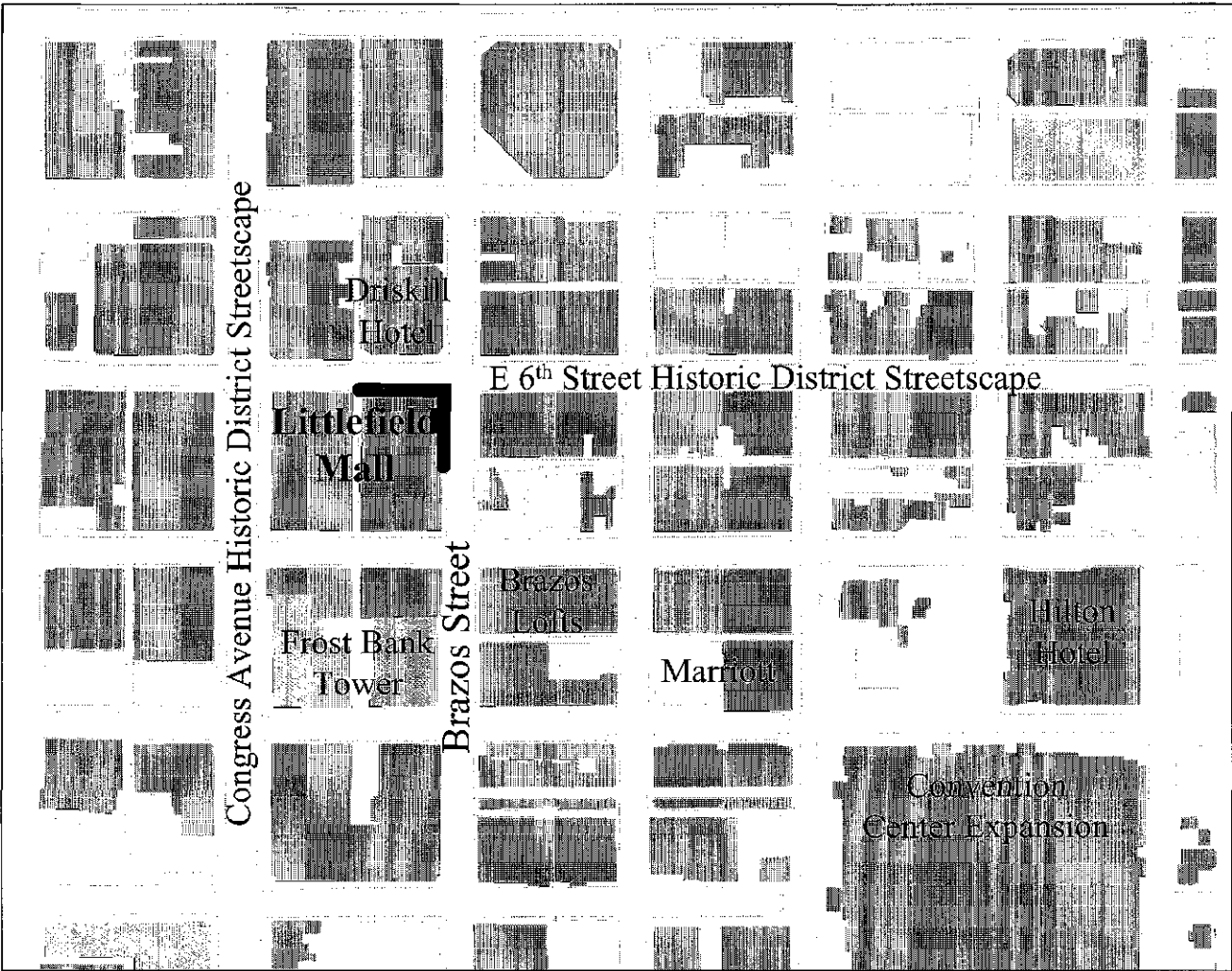
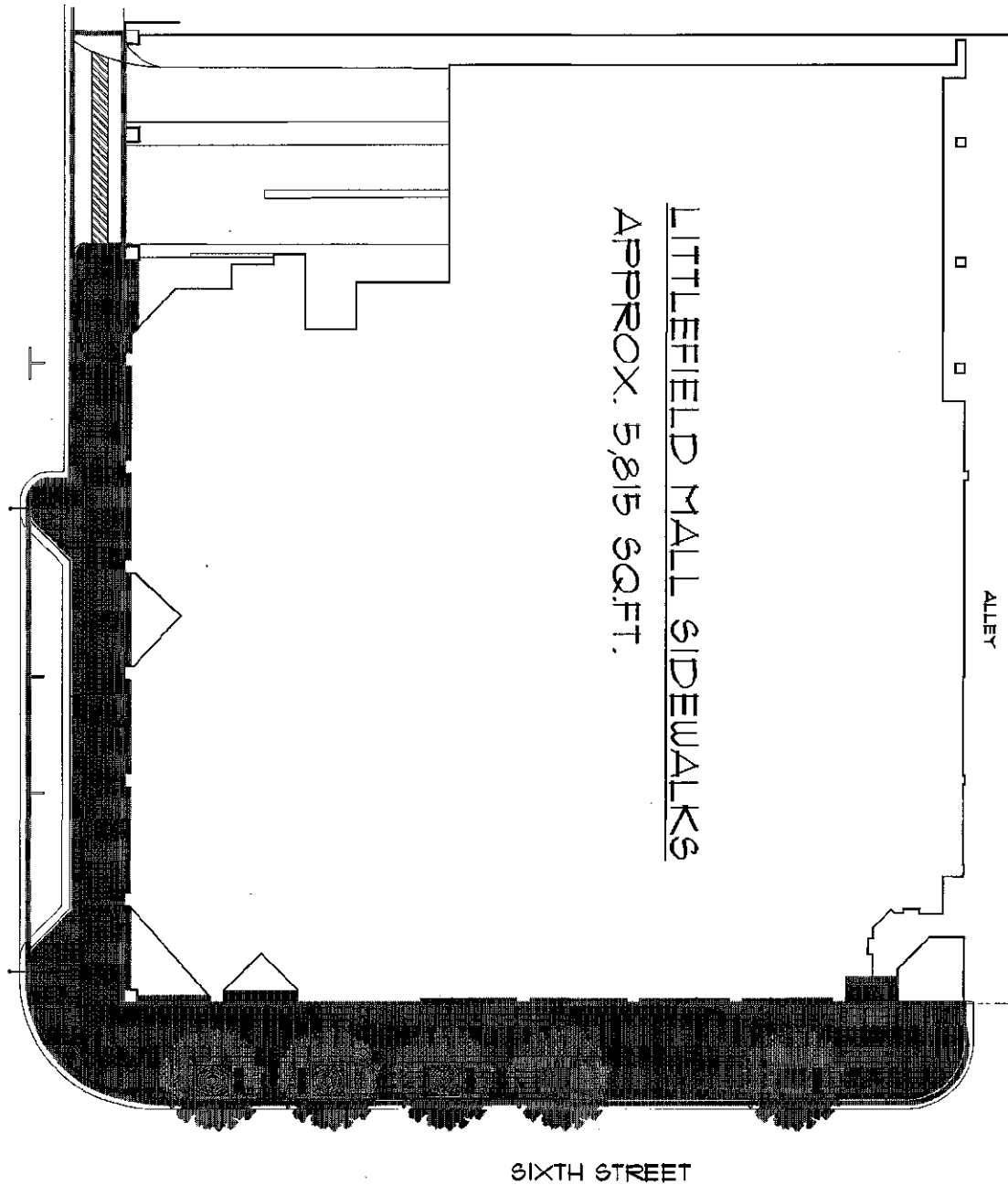


Exhibit B - Streetscape Plan & Improvement Area Calculation


