#### • The Board:

- The Board denied an appeal on the Casa De Luz. Building Official had suspended the Certificate of Occupancy for the establishment for not complying with Fire Code Sections 503.1.1 and 503.2.1. Other noted violations were code section 25-1-361-Certificate Required; 25-11-32-Building Permit required, 25-5-1-Site Plan required and 25-6-471 Off street parking facility required.
- Discussed and made a motion for recommendation to City Council on amendments to Title 25#30 of the City Code related to Floodplain Regulations. But also to include language to consider waiving permit fees for flood damaged properties in the flood plain but not inspection fees.
- Board was briefed in a meeting by the City law office on the process of appeals, posting language and public hearings.
- Board made a motion for recommendation to City Council of the Wildland Urban Interface after a brief change in the recommendation on "ignition resistance materials."
- Board made a recommendation to council to approved 2018 International Swimming Pool and Spa Code Ordinance.

This board does comply with the mission statement and reviews appeals and determinations related to the Building Code, the Fire Code, and other technical codes, which is what helps make Austin one of the most livable cities.
