The Art in Public Places Panel Meeting will be held with Social Distancing Modifications. Public comment will be allowed via telephone; no in-person input will be allowed. All public comment will occur at the beginning of the meeting.

To speak remotely at the Art in Public Places Panel Meeting, residents must:

The information required is the speaker's name, item number(s) they wish to speak on, whether they are for/against/neutral, and a telephone number or email address.
- Once a request to speak has been called in or emailed to the panel liaison, residents will receive either an email or phone call providing the telephone number to call on the day of the scheduled meeting.
- Speakers must call in at least 10 minutes prior to meeting start to speak, late callers will not be accepted and will not be able to speak.
- Speakers will be placed in a queue until their time to speak.
