The Transportation Division of the Transportation, Planning & Sustainability Department has completed an investigation on Fairfield Drive in the vicinity of Lanier High School. Traffic volumes, traffic speeds, and pedestrian volumes and patterns were evaluated in order to determine what, if any modifications could be made to improve the safety of the students attending Lanier High School. As a result of this investigation, the Transportation Division recommends extending the existing school zone on Fairfield Drive to enhance the safety of students.

Amendment to Code Section 12-4-63 (20 MPH School Zone)

Repeal the subsection that reads: Fairfield Drive from 114 feet west of Parkfield Drive to 285 feet east of Parkfield Drive (Lanier High School/Woolridge Elementary School)

Add: Fairfield Drive from 114 feet west of Parkfield Drive to 120 feet east of Bradford Drive (Lanier High School/Woolridge Elementary School).

ORDINANCE NO.

AN ORDINANCE AMENDING SECTION 12-4-63 OF THE CODE TO EXTEND THE SCHOOL ZONE ON FAIRFIELD DRIVE RELATING TO LANIER HIGH SCHOOL AND WOOLDRIDGE ELEMENTARY SCHOOL.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Section 12-4-63 of the City Code is amended to read:

Fairfield Drive from 114 feet west of Parkfield Drive to <u>120 feet east of Bradford</u> <u>Drive</u> [285 feet east of Parkfield Drive] (Lanier High School/Wooldridge Elementary School).

PART 2. The amendments made in this ordinance shall be incorporated in alphabetical order and the existing subsections renumbered accordingly.

PART 3. This ordinance takes effect on ______, 2004.
