- Heard a public hearing and appeal on the La Vista De Lopez project
  where the appellants were appealing the interpretation of the fire code
  and not the site plan.
- Volunteered two board members to assist with Development Services Department(DSD) on the 2021 IBC Ordinance
- Discussed Fence Code Amendments after presentation by the Building Official on future recommendation for fence and material designs.
   Board volunteered Ashley Juraska and Aubrey Brasfield to work in a work group with DSD to work on a resolution for future recommendation of the Board.
- Heard Building Official's interpretation of diving envelope when elevated surfaces are within 4 feet of the water edge.
- Heard the presentation of the Building Official and DSD staff on the proposed ordinance of the IBC, IEBC, IRC, WUI and IPMC
- Heard the Building Official presentation on relocating the language of the IBC appendix G, IBC 1612, IRC R322 and the definitions from the IBC and IRC to Chapter 25-12 to Article 3.
- Involved in discussion with Austin Code on the Repeat Offender Program and expressed interest in participating in work group discussion with the Building Standard Commission.
