- 3. Equitable Transit Oriented Development :** Capital Metro staff [presented](#) on the Equitable Transit Oriented Development study.
- 4. Pedestrian Advisory Council Bylaws Article 5, Section 2 and Article 6, Section 1 Proposed Revision** - PAC Vice-Chair, Chris Anderson led the discussion regarding proposed bylaw changes. The PAC members voted in approval of the bylaw amendment to Article 5 Section 2 and Article 6 Section 1. The vote was approved on a 9-0 vote with Riegel absent.

- 6. McKalla Station Design Discussion and Possible Action:** PAC members discussed the proposed design of McKalla Station.
