Mr. Bill Youngblood appeared before the Council to seek the approval and the funds for a Central Texas Comprehensive Health Planning Commission study. BIDS RECEIVED ON GENERAL OBLIGATION AND REVENUE BONDS

Mayor Akin noted that it was time to receive bids on General Obligation and Revenue Bonds, ascertained the accuracy of the hour, that there were no other bids having been received in the mailing room, the City Manager's Office, by the Finance Director or by the City Clerk's Office, or to be submitted by anyone present in the Council Chamber.

Mr. Charles Babb of the Austin Board of Realtors and Austin Association of Home Builders noted that citizens protesting an ordinance must sign a petition within ten days before the ordinance becomes effective and that all citizens should have the right to be informed of their voting opportunity. Mayor Akin stated that the Real Estate Board had deliberately mislead citizens with the caption "Forced Housing Ordinance" printed in an advertisement in the Austin American.

When the Southern Union Gas Company requires definite information upon the ground as to elevations or working points from which to base the location of their assignments, they shall apply to the Department of Public Works not less than three (3) days before such information is required. The Southern Union Gas Company is further put upon notice that they will be required to bear the expense of repairs or replacement of any underground utility damaged during the construction of lines named in this resolution.

AND THAT all backfill under street surfaces between existing or future proposed curbs and under driveways and alleys, shall be tamped with mechanical tampers in six (6) inch layers. Each layer shall be compacted to not less than 90 per cent of maximum density as determined by the Standard Method of Test for Compaction and Density of Soils, A.A.S.H.O. Designation T 99-49.

THAT the work and laying of said gas mains, including the excavation in the streets, and the restoration and maintenance of said streets after said mains have been laid, shall be under the supervision and direction of the City Manager and under all the pertinent terms and conditions of the certain franchises granted to said company by the City of Austin.
