That the City Clerk be authorized and instructed to record this finding in Section 33.39 of the Traffic Register.

APPROVING PLANS AND SPECIFICATIONS FOR SUCH WORK, AUTHOR-IZING THE CITY MANAGER TO ADVERTISE FOR BIDS, DIRECTING THE PREP-ARATION OF ESTIMATES, INVOKING THE ALTERNATE PROCEDURE PROVIDED BY ARTICLE I, SECTION 5 OF THE CHARTER OF THE CITY OF AUSTIN AND CHAPTER 106 OF THE ACTS OF THE FIRST CALLED SESSION OF THE 40TH LEGISLATURE OF TEXAS, DETERMINING THAT THE COST OF SUCH IMPROVE-MENTS SHALL BE PAID BY THE CITY OF AUSTIN, PROVIDING A METHOD OF REIMBURSING THE CITY OF AUSTIN FOR A PORTION OF SUCH COSTS BY ASSESSMENT OF A PORTION OF SUCH COSTS AGAINST THE PROPERTY ABUT-TING SUCH STREETS OR PORTIONS THEREOF TO BE IMPROVED, AND FOR THE FIXING OF A LIEN TO SECURE PAYMENT OF SUCH ASSESSMENTS, STAT-ING THE TIME AND MANNER PROPOSED FOR PAYMENT OF ALL SUCH COSTS, DIRECTING THE CITY CLERK TO CAUSE A NOTICE OF THE ENACTMENT OF THIS ORDINANCE TO BE FILED IN THE MORTGAGE OR DEED OF TRUST REC-ORDS OF TRAVIS COUNTY, TEXAS, AND DECLARING AN EMERGENCY.

Wilson be and he is hereby authorized to execute on behalf of the City all settlement agreements, covenants not to sue, dismissals and all other documents and instruments necessary or convenient to effectuate such settlement, and to receive on behalf of the City the payments due the City under such settlement.
