The meeting was called to order with Mayor Akin presiding.

Mayor Akin noted that it was time to receive bids on the City of Austin General Obligation Bonds, ascertained the accuracy of the hour, that there were no other bids having been received in the mailing room, the City Manager's Office, by the Finance Director or by the City Clerk's Office, or to be submitted by anyone present in the Council Chamber.

Mayor Akin announced that it was now 10:30 A.M., and the time for receiving bids was closed.

The Council referred the bids to the Finance Director, Bond Counsel and Fiscal Advisor for verification. Later in the Council Meeting, Mr. Curtis Adrian, Fiscal Advisor, reported seventeen bids were received for the General Obligation Bonds. The low bidder was Phelps, Fenn & Company, Rauscher Pierce and Company, Inc. and Associates, with an effective interest rate of 3.9225%. Mr. Adrian reviewed the current bond market, made a comparison of the Bond Buyer and Dow-Jones Average and noted that the City's interest rates were much lower.

ON THIS, the 24th day of August, 1967, the City Council of the City of Austin, Texas, convened in regular session, being open to the public, at the regular meeting place thereof in the City Hall with the following members present:

and with the following absent: <u>none</u>, constituting a quorum; at which time the following among other business was transacted:

The Mayor presented for the City Council's consideration an ordinance authorizing the issuance of \$3,000,000 "CITY OF AUSTIN, TEXAS, GENERAL OBLIGATION: BONDS, SERIES 1967 (No. 248)", dated September 1, 1967, the caption of said ordinance being as follows:

"AN ORDINANCE BY THE CITY COUNCIL OF THE CITY OF AUSTIN, TEXAS, AUTHORIZING THE ISSUANCE OF \$3,000,000 CITY OF AUSTIN, TEXAS, GENERAL OBLIGATION BONDS, SERIES 1967 (NO. 248), DATED SEPTEMBER 1, 1967, FOR THE PURPOSE OF PROVID-ING FUNDS FOR PERMANENT PUBLIC IMPROVEMENTS, TO WIT: \$50,000 FOR ACQUIRING LANDS FOR RIGHTS-OF-WAY FOR STREETS AND BOULEVARDS IN CONNECTION WITH THE STATE HIGHWAY SYSTEM IN THE CITY OF AUSTIN; \$100,000 FOR ENLARGING AND EQUIPPING THE PUBLIC FREE LIBRARY SYSTEM OF THE CITY AND ACQUIRING NECESSARY LANDS FOR EXPANSION THEREOF; \$2,000,000 FOR CONSTRUCTING AND IMPROVING STREETS INCLUDING BRIDGES AND DRAINAGE INCIDENTAL THERETO IN AND FOR SAID CITY OF AUSTIN AND FOR ACQUIRING NECESSARY LANDS THEREFOR; \$200,000 FOR CONSTRUCTING, EQUIPPING AND IMPROVING FIRE STATIONS IN AND FOR THE CITY OF AUSTIN AND ACQUIRING NECESSARY LANDS THEREFOR; \$400,000 FOR CONSTRUCTING, EQUIPPING, IMPROVING AND REPAIRING HOSPITAL BUILDINGS OF THE CITY OF AUSTIN AND ACQUIRING NECESSARY LAND THEREFOR; AND \$250,000 FOR CONSTRUCTING AND IMPROVING PUBLIC PARKS AND PUBLIC PLAYGROUNDS OF THE CITY OF AUSTIN AND FOR CONSTRUCTING, IMPROVING AND REPAIRING BUILDINGS AND OTHER RECREATION FACILITIES OF SAID PARKS AND PLAYGROUNDS AND FOR ACQUIRING NECESSARY LANDS AND EQUIPMENT THEREFOR; PRESCRIBING THE FORM OF THE BONDS AND THE FORM OF THE INTEREST COUPONS; LEVYING A CONTINUING DIRECT ANNUAL AD VELOREM TAX ON ALL TAXABLE PROPERTY WITHIN THE LIMITS OF SAID CITY TO PAY THE INTEREST ON SAID BONDS AND TO CREATE A SINKING FUND FOR THE REDEMPTION THEREOF, AND PROVIDING FOR THE ASSESSMENT AND COLLECTION OF SUCH TAXES; ENACTING PROVISIONS INCIDENT AND RELATING TO THE PURPOSE AND SUBJECT OF THIS ORDINANCE; AND DECLARING AN EMERGENCY."

The ordinance was read and Councilman Long moved that the rule be suspended which requires that no ordinance shall become effective until the expiration of ten days following the date of its final passage, that such ordinance be finally passed and adopted at this meeting, and that, for the reasons recited therein, said ordinance be passed as an emergency measure for the immediate preservation of the public peace, health, safety of the citizens of Austin as permitted by the City Charter. BUILDING STANDARDS COMMISSION RECOMMENDATION POSTPONED

Mr. Charles Richards, an attorney representing Mr. Robert S. Sibley, III and family appeared before the Council to request that they delay any action until October 2- concerning the recommendation from the Building Standards Commission on a substandard house at 1700 Piedmont.

Mr. Richards stated that there was a point of contention concerning ownership of the property, and that it was necessary to establish the rightful ownership before any repairs on the property could be made. Councilman Nichols moved the Council authorize the City Manager to turn the matter over to the Legal Department to take whatever legal jurisdiction necessary for the repairing or demolishing of the house at 1700 Piedmont. Mr. Eskew further stated that the joint owner of the property would probably not be interested in selling it, but that an agreement might be worked out. ELECTRIC SERVICE BOUNDARY LINE HEARING SET

Mr. Rountree stated that a Mr. Ernest Stewart, Jr. had requested a Council hearing of a matter concerning the changing of the boundary line of a service area between the City of Austin Electric Service area and the REA area. The Council agreed to set the hearing on the following Thursday, August 31, 1975, at 10:00 A.M.

WORKABLE PROGRAM

The Council duscussed the plans for the prospective Workable Program. It was pointed out that a short range plan of action had to be developed and submitted and approved of in order to get assistance for grants. A neighborhood analysis and itemization of particular areas of existing deficiencies in the Master Plan would also have to be submitted, but priority would be given to projects that constituted neighborhood improvements as opposed to Community or regional improvements, such as swimming pools and recreational facilities. It was agreed upon that Councilman Nichols be appointed to the 49 member Commission set up to study the program.

FIRE DEPARTMENT

The Council discussed various grievances of the City's Fire Department. Salary comparisons were made between the Police Department and the Fire Department and it was pointed out that a fireman's pay was not only less than a policeman's, but that they were also working fifty-six hour shifts under severe occupational hazards. The Fire Department requested the Council to consider purchasing cars for the District Chiefs, as well, as a pay raise for the firemen.

PARKS AND RECREATION DEPARTMENT BUDGET

Members of the Parks and Recreation Board appeared before the Council expressing the need for additional funds for various projects under the Parks and Recreation Division. The Council agreed that it was necessary for the Parks and Recreation Department to draw up an itemized budget before any action could be taken.

ACQUISITION OF MOPAC RIGHT OF WAY

Councilman LaRue offered the following resolution and moved its adoption:

(RESOLUTION)

A. F. DeLoney et ux, Jeannette W. DeLoney (MoPac Blvd.)

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

That the offer of the owners and claimants of the hereinafter described tracts of land to convey unencumbered fee simple title thereto to the City of Austin in consideration of the cash payment of \$80,000.00 therefor be accepted, and that the City Manager or his designate be and he is hereby authorized to consummate purchase of the following described tracts of land, to-wit:

TRACT I.

The Northeast 106 feet by 125 feet of Lot No. Five (5) in Block No. One (1) of Westfield "A", a subdivision in the City of Austin, Travis County, Texas, according to the map or plat of said subdivision of record in Book 3, Page 107, of the Travis County Plat Records.

TRACT II.

Lot No. Two (2) LESS the South 60.7 feet thereof, in Block No. One (1), of Westfield "A", a subdivision in the City of Austin, Travis County, Texas, according to the map or plat of said subdivision of record in Book 3, Page 107, of the Travis County Plat Records.

TRACT III.

A part of Lot No. Three (3), in Block No. One (1), of Westfield "A", a subdivision of a part of the George W. Spear League, in the City of Austin, Travis County, Texas, according to the map or plat of said subdivision of record in Book 3, Page 107, of the Travis County Plat Records, said property being more particularly described by metes and bounds as follows, to-wit:

BEGINNING at a point 32.7 feet in a southerly direction measured along the East line of Lot 3 from the northeast corner of said Lot 3, which point is the southeast corner of a triangular shaped tract described as Tract 2 in a deed from A. F. DeLoney et ux to L. L. Kerr et ux, dated March 13, 1940, recorded in Volume 644, page 205, Deed Records of Travis County, Texas;

THENCE, North 49° 51' west with the south line of said Tract 2 described in said deed recorded in Volume 644, page 205, and with the north line of a "Tract Two" described in a deed from L. L. Kerr to A. F. DeLoney et ux, dated March 8, 1940, filed for record March 13, 1940, and recorded in the Deed Records of Travis County, Texas, a total of 188.37 feet, more or less, to a point on the west line of Lot 3, 6.32 feet in a southerly direction measured along the west line of said Lot 3 from the northwest corner thereof:
