Heather,

Folks in the Pioneer Crossing West Nextdoor group alerted me to the fact that there are plans to rezone a 16 acre parcel off Sprinkle Cutoff to allow for a 185-unit condominium project.

First off, I do support this happening. I am not one of those NIMBY types that opposes everything that isn't SFH. I think that condominiums could be an excellent addition to the area for those that cannot afford a SFH. Frankly, I would not be living in a SFH today if I had not bought in early 2020. I live on Bachman Dr, just a few blocks from the parcel of land. I frequently drive down Chetco and head South on Sprinkle Cutoff to go to 290.

The issue I do have is that the Sprinkle Cutoff road itself is not in a good enough condition to allow for the increased traffic an 185-unit condominium project would bring. A light at Samsung & Sprinkle Cutoff may need to be installed. More importantly, the roads in the general area need improvement and expansion to allow for this and future projects. Those roads being Sprinkle Cutoff, Sprinkle Road, Ferguson Rd, Springdale Rd, Cameron Rd, Blue Goose Rd and E Yager Ln.

Until all the roads in the area are overhauled and improved upon, the area will be limited to being the backroad county it is today and has been for many years.

Thank you for including me in the COZ Zoning Meeting Announcement. At this time, I am not planning to speak at the May 17th Agenda Meeting. I would like to still make it known that due to the traffic issue that I brought up in my Feb 23rd, 2022 email, I would prefer to have the parcel of land either remain designated as RR or redesignated as SF-1 to SF-3. Sprinkle Cutoff Rd is a small 2-lane thoroughfare with high traffic from residents at Pioneer Crossing West and East, Pioneer Hills, and Harris Branch. If the developers wish to construct **185-unit condominiums** within the 16.5 acre parcel which their application states the sudden increase of motorists through the roadway will be congested and dangerous.
