- 4.8% Retail Reduction in FY 2018
- No rate increase for 5 years (FY 2019 FY 2023)

Staffing Plan Increase

• Significant increase in budgeted FTEs despite high vacancy rate

Significant Increase in Inter-department Transfers

 In FY 2022, transfers for CTECC, CTM, Regional Radio and CPM increases ranged from 12% to 42%

Growing Capital Plan

- Several large strategic projects on the horizon
- Construction costs continue to rise

Hiring and Attrition

Vacancies – FY 22

- Beginning of Year 138 (includes 62 new FTEs for FY)
- Current 151 (includes April budget amendment for 16 new FTEs)

Hiring – 189 position filled year to date






