PROPOSAL

Demolish a pre-WWII farmhouse.

ARCHITECTURE

One-story house with asbestos shingle siding, covered stoop, pyramidal hipped roof, and exposed rafter tails.

RESEARCH

The house at 1010 Springdale Road, addressed historically as 3707 Goodwin Avenue, was built prior to 1940 for William P. and Carolyn Goodwin. William Goodwin, son of pioneer farmer William C. Goodwin, operated a farm and dairy. Carolyn A. Goodwin, known as Carrie, commuted into Austin to work as a clerk at the Attorney General's office. The Goodwin family owned the property until at least 1980. Before 1984, it was sold to a petrochemical transport company.

PROPERTY EVALUATION


Designation Criteria—Historic Landmark

- 1) The building is more than 50 years old.
- 2) The building appears to retain moderate integrity; however, its integrity of setting has been compromised.
- 3) Properties must meet two criteria for landmark designation (LDC §25-2-352). Staff has evaluated the property and determined that it does not meet two criteria:
 - a. Architecture. The building does not appear to convey architectural significance.
 - b. Historical association. The property is associated with the Goodwin family.
 - c. Archaeology. The property was not evaluated for its potential to yield significant data concerning the human history or prehistory of the region.
 - d. Community value. The property does not possess a unique location, physical characteristic, or significant feature that contributes to the character, image, or cultural identity of the city, the neighborhood, or a particular demographic group.
 - e. Landscape feature. The property is not a significant natural or designed landscape with artistic, aesthetic, cultural, or historical value to the city.

STAFF RECOMMENDATION

Approve the demolition application upon completion of a City of Austin Documentation Package.




Demolition permit application, 2022 (rear of building)

William C. Goodwin, 79, a pioneer farmer of Travis county, died at the family home Saturday afternoon following an illness of several months. He is survived by his widow; three daughters, Mrs. L. A. Cook and Mrs. Charles Pickle of Austin and Miss Anna Goodwin of Del Valle; three sons, W. P. Goodwin of Govalle and A. J. Goodwin and E. C. Goodwin of Austin; and two brothers, Alvin and Alex Goodwin of Georgia.

Funeral services will be held from the Cook funeral home Monday at 10 a. m. with the Rev. George Green officiating. Burial will be in Oakwood.

5-Minute Schedules Run Daily

Four downtown firms Monday will inaugurate a new public service by providing free shuttle buses from three stops in the state office area to a central location at Fifth and Congress Avenue during the lunch hours.

The shuttle buses will leave the Capitol area every five minutes beginning at 11:30 a.m. Mondays through Fridays and return every five minutes until 1 p.m.

The merchants providing the service are The Marie Antoinette, Scarbrough and Sons, T. H. Williams and Yarings. The firms will use chartered buses of the Austin Transit Company. Buses will be marked with signs and pennants to distinguish them from regular buses.

Stops will be made in front of the Land Office Building, in front of the Capitol and in front of the Tribune Building. The trip to Fifth and Congress, the only stop in the shopping area, will take only a few minutes. The returning buses will take passengers to the three initial stops in the office area.

The buses are absolutely free to all persons. The four firms believe the new service will help workers get downtown and return to their jobs during their noon hours by eliminating the extra time spent in seeking parking places or walking.

No identification or purchase slips are necessary to board the buses.
