

MINUTES OF THE CITY COUNCIL

CITY OF AUSTIN, TEXAS

Regular Meeting

August 8, 1957
10:00 A.M.

Council Chamber, City Hall

The meeting was called to order with Mayor Miller presiding.

Roll call:

Present: Councilmen Long, Palmer, Pearson, White, Mayor Miller

Absent: None

Present also: W. T. Williams, Jr., City Manager, Doren R. Eskew, City Attorney; Reuben Rountree, Jr., Director of Public Works.

Invocation was delivered by REV. DON BENTON, First Methodist Church, 1200 Lavaca Street.

Councilman White moved that the Minutes of August 1st be approved. The motion, seconded by Councilman Pearson, carried by the following vote:

MR. BERNARD TRAYNOR, representing EARL HAYES RENT-A-CAR, appeared before the Council asking for space at the Airport, and submitting a plan for revising the space now occupied by two other rent-a-car-systems where by it would accomodate the third, and offering to pay for the revision, and offering \$150.00 a month rental. He stated 23 airlines used their service exclusively, and bought it with their tickets. The Council suggested that it might be better to wait until the new Terminal was completed; but in the meantime it would discuss the matter with the two operators now renting at the Airport, and give Mr. Traynor and Mr. Catchings an answer next week. The Mayor asked that the City Manager see if these cars are all registered in Austin. (Earl Hayes local agent for Avis Rent-a-Car.)

MR. JOE NEAL, University of Texas, introduced a group of about 50 foreign students. The Mayor and Council greeted and welcomed the group.

AN ORDINANCE AMENDING THAT CERTAIN ORDINANCE PASSED BY THE CITY COUNCIL OF THE CITY OF AUSTIN, TEXAS, JULY 17, 1941, AND RECORDED IN ORDINANCE BOOK "L", PAGES 152-174, INCLUSIVE, OF THE ORDINANCE RECORDS OF THE CITY OF AUSTIN, WHICH ORDINANCE WAS AMENDATORY OF THAT CERTAIN ORDINANCE ESTABLISHING ZONING REGULATIONS AND DISTRICTS IN ACCORDANCE WITH A COMPREHENSIVE PLAN PASSED BY THE CITY COUNCIL, APRIL 23, 1931, AND RECORDED IN BOOK "I", PAGES 301-318, INCLUSIVE, OF THE ORDINANCE RECORDS OF THE CITY OF AUSTIN, THE AMENDATORY ORDINANCE HEREBY CHANGING THE USE DESIGNATION FROM "D" INDUSTRIAL DISTRICT TO "C-1" COMMERCIAL DISTRICT ON A TRACT OF LAND FRONTING APPROXIMATELY 433 FEET ALONG THE NORTH RIGHT OF WAY LINE OF EAST FIFTH STREET, LOCALLY KNOWN AS 5210-5318 EAST FIFTH STREET, IN THE CITY OF AUSTIN, TRAVIS COUNTY, TEXAS; ORDERING A CHANGE IN THE USE MAPS SO AS TO RECORD THE CHANGE HEREBY ORDERED; AND SUSPENDING THE RULE REQUIRING THE READING OF ORDINANCES ON THREE SEPARATE DAYS.

The ordinance was read the second time and Councilman Pearson moved that the ordinance be passed to its third reading. The motion, seconded by Councilman White, carried by the following vote:

AN ORDINANCE AMENDING THAT CERTAIN ORDINANCE PASSED BY THE CITY COUNCIL OF THE CITY OF AUSTIN, TEXAS, JULY 17, 1941, AND RECORDED IN ORDINANCE BOOK "L", PAGES 152-174, INCLUSIVE, OF THE ORDINANCE RECORDS OF THE CITY OF AUSTIN, WHICH ORDINANCE WAS AMENDATORY OF THAT CERTAIN ORDINANCE ESTABLISHING ZONING REGULATIONS AND DISTRICTS IN ACCORDANCE WITH A COMPREHENSIVE PLAN PASSED BY THE CITY COUNCIL APRIL 23, 1931, AND RECORDED IN BOOK "I", PAGES 301-318, INCLUSIVE, OF THE ORDINANCE RECORDS OF THE CITY OF AUSTIN, THE AMENDATORY ORDINANCE HEREBY ESTABLISHING THE BOUNDARIES FOR VARIOUS ORIGINAL USE DISTRICTS AND HEIGHT AND AREA DISTRICTS IN AREAS ANNEXED TO THE CITY OF AUSTIN ON SEPTEMBER 8, 1955, AND TIMES SUBSEQUENT THERETO, EXCEPT AREA 4, WHICH WAS ANNEXED ON DECEMBER 16, 1948; ORDERING A CHANGE IN THE USE AND HEIGHT AND AREA MAPS SO AS TO RECORD SUCH DISTRICTS; AND SUSPENDING THE RULE REQUIRING THE READING OF ORDINANCES ON THREE SEPARATE DAYS.

The ordinance was read the first time and Councilman Pearson moved that the rule be suspended and the ordinance passed to its second reading. The motion, seconded by Councilman White, carried by the following vote:

The Council noted that the public hearing on the original zoning of Area 6 (46.44 acres in northwest part of town, -Shepperd, Deason, Barrow, Keller, et al) had been reset from August 22nd, to 11:00 A.M., AUGUST 29, 1957. The Council approved of the resetting.

"All bidders quoted net 30 days. Southern Electric quoted a firm price. Westinghouse quoted a firm price for ninety (90) days following any price increase. General Electric and Graybar Electric Company quoted a firm price

for ninety (90) days subject to a 10% escrow for shipment over 90 days, but less than one year. Priester Supply Company quoted a maximum price provided shipment is accepted within six (6) months from date of order. Priester Supply, Graybar Electric Company and General Electric Company quoted FOB Austin, Westinghouse quoted FOB destination, and Southern Electric Supply quoted FOB substation base, stating that the regulator will be set on their foundations in the desired position.

"Southern's delivery date is satisfactory.

"On the basis of delivery to the regulator base at the substation, I recommend that a contract be awarded to Southern Electric Supply Company, a local bidder, for the purchase of four (4) 500/625 KVA regulators at firm price of \$20,627.00 each.

Davis Survey Abstract 217, of record in Book 4 at page 333 of the Plat Records of Travis County, Texas; and,

WHEREAS, the owner of the hereinafter described premises has requested that said electric easements located thereon be released; and,

WHEREAS, the hereinafter described portions of said easements are not now needed and hereafter will not be required by the City of Austin; Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

That W. T. Williams, Jr., City Manager, be and he is hereby authorized and directed to execute a release of the electric easements located on the hereinafter described strips of land, to wit:

No. 1: The east five (5.00) feet of Lot 11, Block 8 of Green Acres;

No. 2: The west five (5.00) feet of Lot 10, Block 8 of Green Acres;

No. 3: The east five (5.00) feet of Lot 4, Block 10 of Green Acres; and

No. 4: The west five (5.00) feet of Lot 3, Block 10 of Green Acres.

"Subject: Rebuilding Clarifier at Filter Plant No. 1

"The clarifier equipment at Filter Plant No. 1 which was installed in 1941 is badly in need of repair which will require extensive replacement of parts. The existing equipment was manufactured and furnished by Dorr-Oliver Incorporated.

"I have asked Dorr-Oliver for a quotation on the necessary replacement parts. They have given us a quotation in the amount of \$5,067.00 for replacement of a minimum number of parts (to make the equipment serviceable for a few years); a quotation in the amount of \$8,388.00 for replacement of all worn and corroded parts (to make the equipment as serviceable as new equipment); and a quotation in the amount of \$10,587.00 for replacement of all worn and corroded parts plus the addition of two corner arm assemblies (which we do not believe to be of any particular value to us).

"I have also asked the three chief competitors of Dorr-Oliver in the manufacture of this type of equipment for quotations covering replacement parts. Without exception they have declined to quote, giving as their reason that engineering and other costs to adapt their equipment to the existing equipment would make their prices prohibitive. Their letters are enclosed herewith.

"It is estimated that the cost of completely new clarifier equipment for this installation would be approximately \$16,000.00

"Recommendation:

"It is my recommendation that the Dorr-Oliver quotation in the amount of \$8,388.00, f.o.b. Austin covering the furnishing of replacement parts to make the equipment as serviceable as new equipment be accepted.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

That the bid of Dorr-Oliver in the amount of \$8,388.00 f.o.b. Austin for the furnishing of replacement parts be and the same is hereby accepted.

WHEREAS, the City of Austin has heretofore on the 14th day of June, 1957 entered into a contract with Joe Bland Construction Company for the construction of improvements to the City's public water distribution system across and south of the Colorado River; and,

WHEREAS, because of an emergency created by a break in a twenty-four inch water main where said main crosses the Colorado River, the City's engineers and the City Manager have prepared Change Order No. 1, and recommended that certain changes in the nature of extra work be made in the contract as awarded to said Joe Bland Construction Company, so as to provide for the installation of a new twenty-four inch cast iron, ball and socket type, special submarine pipe upstream from, and for the removal of, the existing twenty-four inch cast iron bell and spigot type water main across the Colorado River upstream from the I.&G.N. Railroad Bridge; and,

WHEREAS, the City Council has considered and desires to approve the execution and delivery of such Change Order by the City Manager; Now Therefore

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

That the City Manager, W. T. Williams, Jr. be and he is hereby authorized and directed to execute and deliver to said Joe Bland Construction Company said Change Order No. 1, to be dated August 7, 1957, so as to provide for said extra work in the amount of \$2,576.00 for the removal of the twenty-four inch bell and spigot water main, and \$57,960.00 for the installation of the new ball and socket special submarine water main.
