The meeting was called to order with Mayor Miller presiding.

Councilman White moved that MR. PAT DOUGHERTY be reappointed as Judge of the Corporation Court. The motion, seconded by Councilman Pearson, carried by the following vote: Ayes: Councilmen Long, Palmer, Pearson, White Mayor Miller Noes: None

Councilman Pearson moved that MR. W. A. WILLIAMSON be reappointed Clerk of the Corporation Court; MR. VERNIE SMITH and MISS ANN BUTLER be reappointed Deputy Clerks of the Corporation Court. The motion, seconded by Councilman White, carried by the following vote:

Councilman Long moved that DR. BEN PRIMER be reappointed Health Officer. The motion, seconded by Councilman White, carried by the following vote:
