

## MINUTES OF THE CITY COUNCIL

CITY OF AUSTIN, TEXAS

Regular Meeting

March 12, 1959  
10:00 A.M.

Council Chamber, City Hall

The meeting was called to order with Mayor Miller presiding.

Roll call:

Invocation was delivered by The REV. EVERETT G. SMITH, Holy Trinity Episcopal Church, Woodland and Summitt Streets.

Councilman White moved that the Minutes of the Meeting of March 5, 1959, be approved. The motion, seconded by Councilman Pearson, carried by the following vote:

The Council received the following request from MR. B. I. GASTON, President of the Capitol Aeroneers:

"Dear Sirs:

"On behalf of the Capitol Aeroneers, an Austin model airplane club, I, as president of this organization, am requesting you permission and approval of holding a model airplane contest, open to all A.M.A.<sup>1</sup> members, on July 4, 1959, at the Austin Municipal Airport.

"The areas of the airport we wish to use are: the grass field southeast of the Ragsdale Office Building, between the old P-38 and the amphibian; also, the ramp area immediately north of the main Ragsdale hangar.<sup>3</sup>

"Mrs. Ragsdale and the Ragsdale Flying Service have generously approved this proposal. Col. Murphy also has indicated his approval.

"This airplane meet will be under the existing A.M.A. rules, which takes into consideration the important factor of safety. Only A.M.A. members<sup>2</sup> will participate, and each of the members has public liability and property damage insurance. As members of the A.M.A., I can assure you the contest will be sanctioned by the national headquarters and conducted in a business-like manner.

After discussion, Councilman Long moved to grant the permission with the City Manager working out the details. The motion, seconded by Councilman White, carried by the following vote:

MR. GRADY RYLANDER appeared before the Council regarding a traffic hazard at his home at 3409 Foothills Terrace and Edgemont. He stated the cars came down the hill on Edgemont at a terrific speed and were unable to stop, and either go way into his drive or in his yard. He requested permission to build a non-standard curb on the curblin, or behind the curblin, or where the City would give permission. He listed other locations where there were retaining walls or irregular curbs--5500 Caprice; 3416 Hillview on 35th Street; Corner of Townes Lane and Winsted; and 2309 Windsor Road, and others. The Council noted the problem and the Mayor stated it would go out and make another inspection of the situation and see what can possibly be done.

Councilman Palmer offered the following resolution and moved its adoption:

(RESOLUTION)

WHEREAS, by resolution adopted on August 14, 1958, the Council authorized James Russell Horton as administrator of Brackenridge Hospital to execute applications to the United States of America for permits to use alcohol, free of tax; and

WHEREAS, since the appointment of a new administrator for Brackenridge Hospital, there has been no person duly authorized to execute such permits, Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

That the duly appointed Administrator of Brackenridge Hospital, by the City Manager from time to time, be and he is hereby authorized to execute in behalf of the City of Austin, applications to the United States of America, for permits to use alcohol, free of tax, in Brackenridge Hospital, a hospital owned and operated by the City of Austin in Austin, Texas.

The Council had before it the following tabulation of the bids received for the construction of a low water dam and Holly Street Power Station and for power piping and for power wiring:

"Proposals for the Low Water Dam, Contract No. 80 and Holly Street Power Station, Contract No. 64, Site Improvement and Structures, Contract No. 65, Power Piping and Contract No. 66, Power Wiring, were received and publicly opened at 2:00 P.M., March 9, 1959.

"A tabulation of the bids is attached.

"One bid in the sum of \$4,416,415 was submitted by H. B. Zachry on all

or none basis for the award of all four contracts. This bid for Contract Nos. 80, 64, 65 and 66 was lower than any combination of low individual bids for these contracts.

"We concur with the recommendations of Mr. D. N. Higgins, Chief Power Engineer of Brown & Root, Inc., our consultants on both the Holly Street Power Station and the Low Water Dam, that the Low Water Dam Contract No. 80 and the Holly Street Power Station, Contract Nos. 64, 65 and 66 be awarded to the lowest bidder, H. B. Zachry for the sum of \$4,416,415.

"Dear Mr. Kinney:

"Bids for construction for Unit No. 1 of Holly Street Power Station and the Low Water Dam were opened at 2:00 P.M., March 9, 1959. Included were the following contracts:

Contract No. 64 - Site Improvement & Structures  
Contract No. 65 - Power Piping  
Contract No. 66 - Power Wiring  
Contract No. 80 - Low Water Dam

"Attached is a bid tabulation showing unit prices for the individual contracts; for a combined contract to include Contract Nos. 64, 65 and 66, and for a combined contract to include Contract Nos. 64, 65, 66 and 80 as provided in Addendum No. 1 to the Specifications.

"Quotations were also received for deductions to Contract No. 65 or to the combined contract of Contract Nos. 64, 65, and 66 for boiler erection. These were procured only to permit a comparison with the quotation for boiler erection by the boiler vendor, Combustion Engineering, Inc., submitted as an attachment to their boiler proposal. All of the three low bidders gave deductions which were lower than the price quoted by Combustion.

"The lowest bid was submitted by H. B. Zachry Company for a combined contract, consisting of Contract Nos. 64, 65, 66 and 80. Individual unit prices as required by Addendum No. 1 to the specifications were also submitted. However, it was stipulated by Zachry in his proposal that these unit prices were included only for information, and that the contract would be accepted on an all or nothing basis.

"It is recommended that the lowest bid be accepted and that Contract Nos. 64, 65, 66 and 80 be awarded to the low bidder, H. B. Zachry Company, for the lump sum bid of \$4,416,415.00.

The City Manager also read a letter from H. B. Zachry Company, which letter accompanied the bid, and which was referred to on each proposal sheet. A detailed discussion was held on the bids. Inquiry and protest of the "all or none" low bid were made by MR. WARREN, representing the Natkin Company, low on the separate bid on power piping; MR. W. K. JENNINGS, low bidder on separate bid on power wiring; and MR. BILL SHELTON, representative of Farnsworth & Chambers, second low bidder on combined bids on the power plant and third on the dam, stating the combination power plant and dam proposal was a qualified proposal; and as such had rendered an unfair advantage to a low bidder, and also stating that the letter attached to the H. B. Zachry Company bid was not read at the opening of the bids. MR. BUCK AVERY, made inquiry if any written protest had been filed and it was stated one letter from J. M. ODOM GENERAL CONTRACTORS, dated March 10, 1959, had been received by the City Manager. A review of the bids sent out, and of the bid of Combustion Engineers, and others matter was made.

MR. J. H. BLACKALLER, Vice President, H. B. Zachry Company, made explanations of the various points brought up about their bid. MR. SCHUTZE stated he was present at the bid opening and understood Mr. Zachry to say verbally that the bid was "all or none", and that he had asked Mr. Kinney to look at the proposition to see if there was a quotation on that basis. The letter was with the bid at that time. He made inquiry as to whether or not the bid had been higher than the combination of other bidders, would Mr. Zachry have had the right of taking any part of the contract that he so desired. The City Attorney stated he would not have been given the opportunity. MR. BLACKALLER stated both union and non-union skilled labor were working with the Company, and that it was the Company's intent to give as much business to the suppliers and subcontractors of Austin and employ as many people from this area as they could; that the Company paid the prevailing wage scale or better.

MR. HIGGINS, Consulting Engineer, Brown and Root, explained his recommendation. Mayor Miller stated the Council was very much pleased to have these wonderful bids and appreciated the companies' bidding.

Councilman Palmer offered the following resolution and moved its adoption:

(RESOLUTION)

WHEREAS, on March 9, 1959, the City of Austin received bids for the construction of a Low Water Dam, Contract No. 80, and Holly Street Power Station, Contract No. 64, for site improvement and structures, Contract No. 65 for power piping and Contract No. 66 for power wiring; and,

WHEREAS, the bid of H. B. Zachry in the total sum of \$4,416,415.00 was the lowest and best bid therefor, and the acceptance of such bid has been recommended by Brown & Root, Inc. Consulting Engineers for both the Low Water Dam and the Holly Street Power Station, and by the Director of Electric Utility of the City of Austin, and by the City Manager; Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

That the bid of H. B. Zachry in the sum of \$4,416,415.00 be and the same is hereby accepted, and W. T. Williams, Jr., City Manager of the City of Austin is hereby authorized and directed to execute a contract on behalf of the City of Austin with H. B. Zachry.

AN ORDINANCE AMENDING THAT CERTAIN ORDINANCE PASSED BY THE CITY COUNCIL OF THE CITY OF AUSTIN, TEXAS, JULY 17, 1941, AND RECORDED IN ORDINANCE BOOK "I", PAGES 152-174, INCLUSIVE, OF THE ORDINANCE RECORDS OF THE CITY OF AUSTIN, WHICH ORDINANCE WAS AMENDATORY OF THAT CERTAIN ORDINANCE ESTABLISHING ZONING REGULATIONS AND DISTRICTS IN ACCORDANCE WITH A COMPREHENSIVE PLAN PASSED BY THE CITY COUNCIL APRIL 23, 1931, AND RECORDED IN BOOK "I", PAGES 301-318, INCLUSIVE, OF THE ORDINANCE RECORDS OF THE CITY OF AUSTIN, THE AMENDATORY ORDINANCE HEREBY ESTABLISHING THE BOUNDARIES FOR AN ORIGINAL USE DISTRICT AND HEIGHT AND AREA DISTRICT, IN AREAS ANNEXED TO THE CITY OF AUSTIN ON JUNE 20, 1957, AND SUBSEQUENT TIMES THERETO; ORDERING A CHANGE IN THE MAPS SO AS TO RECORD SUCH DISTRICTS; AND SUSPENDING THE RULE REQUIRING THE READING OF ORDINANCES ON THREE SEPARATE DAYS.

AN ORDINANCE AMENDING THAT CERTAIN ORDINANCE PASSED BY THE CITY COUNCIL OF THE CITY OF AUSTIN, TEXAS, JULY 17, 1941, AND RECORDED IN ORDINANCE BOOK "L", PAGES 152-174, INCLUSIVE, OF THE ORDINANCE RECORDS OF THE CITY OF AUSTIN, WHICH ORDINANCE WAS AMENDATORY OF THAT CERTAIN ORDINANCE ESTABLISHING ZONING REGULATIONS AND DISTRICTS IN ACCORDANCE WITH A COMPREHENSIVE PLAN PASSED BY THE CITY COUNCIL, APRIL 23, 1931, AND RECORDED IN BOOK "I", PAGES 301-318, INCLUSIVE, OF THE ORDINANCE RECORDS OF THE CITY OF AUSTIN, THE AMENDATORY ORDINANCE HEREBY CHANGING THE FOLLOWING:

(1) A TRACT OF LAND FRONTING 50 FEET ON THE WEST RIGHT OF WAY LINE OF LAMAR BOULEVARD, LOCALLY KNOWN AS 5528-5530 LAMAR BOULEVARD, FROM "C-1" COMMERCIAL DISTRICT TO "C-2" COMMERCIAL DISTRICT; (2) LOTS 11, 12 AND 29, AND THE EAST 41 FEET OF LOTS 10, 13 AND 28, STANHOPE PLACE, FROM "A" RESIDENCE DISTRICT TO "O" OFFICE DISTRICT; (3) TWO IRREGULAR LOTS, SAME BEING ALL OF LOTS 4 AND 5, RESUBDIVISION OF OWENS NUMBER 1, SECTION ONE, FROM "A" RESIDENCE DISTRICT AND FIRST HEIGHT AND AREA TO "B" RESIDENCE DISTRICT AND SECOND HEIGHT AND AREA DISTRICT; (4) A TRACT OF LAND FRONTING 104.3 FEET ON THE EAST RIGHT OF WAY LINE OF LAMAR BOULEVARD AND APPROXIMATELY 150 FEET ON THE NORTH RIGHT OF WAY LINE OF BEAVER STREET, LOCALLY KNOWN AS 8601-8607 LAMAR BOULEVARD AND 710-720 BEAVER STREET, FROM "C" COMMERCIAL DISTRICT AND FIRST HEIGHT AND AREA DISTRICT TO "C-1" COMMERCIAL DISTRICT AND SIXTH HEIGHT AND AREA DISTRICT; (5) LOT 7, BLOCK 5, LORRAINE HEIGHTS, FROM "A" RESIDENCE DISTRICT TO "B" RESIDENCE DISTRICT; (6) THE SOUTH 62.5 FEET OF LOT 1, BLOCK 2, ELM GROVE ADDITION, FROM "A" RESIDENCE DISTRICT TO "GR" GENERAL RETAIL DISTRICT; (7) TWO TRACTS OF LAND FRONTING 142.9 FEET ON THE EAST RIGHT OF WAY LINE OF CAMERON ROAD, LOCALLY KNOWN AS 5207-5209 CAMERON ROAD, FROM "A" RESIDENCE DISTRICT AND FIRST HEIGHT AND AREA DISTRICT TO "GR" GENERAL RETAIL DISTRICT AND SIXTH HEIGHT AND AREA DISTRICT; (8) LOTS 1-6, BLOCK 6, WILSON SUBDIVISION, FROM "GR" GENERAL RETAIL DISTRICT TO "C-1" COMMERCIAL DISTRICT; AND (9) LOTS 1-4, BLOCK 25, ORIGINAL CITY OF AUSTIN, FROM "LR" LOCAL RETAIL DISTRICT TO "C" COMMERCIAL DISTRICT; ALL OF SAID PROPERTY BEING LOCATED IN AUSTIN, TRAVIS COUNTY, TEXAS; ORDERING A CHANGE IN THE USE AND HEIGHT AND AREA MAPS SO AS TO RECORD SUCH CHANGES; AND SUSPENDING THE RULE REQUIRING THE READING OF ORDINANCES ON THREE SEPARATE DAYS.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

That the application of the City National Bank of Austin, Texas, to construct and maintain an underground pneumatic tube system in and under a part of that certain alley, locally known as Congress Avenue Alley, said alley lying east of and parallel to Congress Avenue and traversing Block 97 of the Original City of Austin according to a map or plat of said Original City of Austin on file in the General Land Office of the State of Texas; such system not to exceed a width of two (2) feet; the centerline of said assignment being more particularly described as follows:

BEGINNING at a point in the east line of said alley and from which point of beginning the point of intersection of the east line of said alley with the south line of East 9th Street bears North 19° 00' East 44.50 feet;

THENCE with the centerline of the said strip of land two (2) feet in width, North 71° 00' West 20.00 feet to point of termination on the west line of said alley.

be and the same is hereby granted and the Building Inspector is hereby authorized to issue a permit for the construction of such improvement, said grant and permit to be subject to the following conditions:

(1) The improvement shall be constructed and maintained in compliance with all ordinances relating thereto.

(2) The permit shall be issued and accepted subject to all reasonable police, traffic, fire and health regulations of the City of Austin, now existing or hereafter adopted.

(3) The repair or relocation of any and all utilities in the vicinity necessitated by the laying of this improvement shall be done at the expense of the City National Bank of Austin, Texas.

(4) The City National Bank of Austin, Texas, will indemnify and save the City of Austin harmless from any and all claims against said City growing out of or connected with the construction or maintenance of said improvement.

(5) The City of Austin may revoke such permit for good cause after notice to the City National Bank of Austin, Texas, and hearing thereon, and upon such revocation the owner of such improvement will remove the same and pay all costs and expenses attendant therewith.

(4) That "No Parking" signs shall be placed on the street side of the barricades.


