MINUTES OF THE CITY COUNCIL

CITY OF AUSTIN, TEXAS

Special Meeting

August 11, 1959 2:30 P.M.

Council Chamber, City Hall

The meeting was called to order with Mayor Miller presiding.

Roll call:

Present: Councilmen Perry, White, Mayor Miller

Absent: Councilmen Bechtol, Palmer (as they were out of the city)

Present also: W. T. Williams, Jr., City Manager; Doren R. Eskew, City Attorney.

The Mayor announced that this meeting was called to hear the Telephone Company present statements in answer to DR. ROBERT MONTGOMERY'S report to the Council on August 5th.

MR. ED CLARK, local Attorney for the Southwestern Bell Telephone Company, thanked the Council for the privilege of coming back to answer Dr. Robert Montgomery's statements, and stated the Company had expert witnesses to appear this afternoon.

(Transcript of this hearing made by regular court reporter)

MR. ED GOSSETT, General Counsel, Southwestern Bell Telephone Company, discussed directory advertising as to whether or not it should be included in the revenues for Austin; the fair value of property on which a fair rate of return should be allowed; the bookkeeping and accounting procedures used which have been approved, and which are constantly being examined by the F.C.C., F.P.C., Rate Making Commissions, etc.; the three types of depreciation referred to in Dr. Montgomery's report; and the separation procedures used by the Company.

MR. WHITNEY R. HARRIS, General Solicitor, put on the technical testimony with sworn witnesses, MR. HOWARD T. COX, C.P.A., and President of the Capital National Bank; and MR. HOUSTON CASKIE, Assistant Treasurer of the Telephone Company. Mr. Harris, in connection with the testimony, filed the following exhibits:
