### MINUTES OF THE CITY COUNCIL

Regular Meeting

The meeting was called to order with Mayor Miller presiding.

Donald Frances is the Contractor for the painting of a building located at 522 Congress Avenue and desires a portion of the sidewalk and street space abutting Lots 4, 5, 6, and the north 16 feet of Lot 3, Block 55, of the Original City of Austin, Travis County, Texas, during the painting of the building, such space to be used in the work and for the storage of materials therefor: therefore

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

1. THAT space for the uses hereinabove enumerated be granted to said

J. Donald Frances, the boundary of which is described as follows:

# Sidewalk and Street Working Space

Beginning at the southeast corner of the above described property: thence in an easterly direction and at right angles to the center line of Congress Avenue to a point 4 feet west of the west curb line; thence in a northerly direction and parallel with the center line of Congress Avenue approximately 154 feet to a point; thence in a westerly direction and at right angles to the center line of Congress Avenue to the northeast corner of the above described property; thence in a northerly direction and at right angles to the center line of West 6th Street to a point 4 feet south of the south curb line; thence in a westerly direction parallel with the center line of West 6th Street 160 feet to a point; thence in a southerly direction and at right angles to the center line of West 6th Street to the northwest corner of the above described property.

- 2, THAT the above privileges and allotment of space are granted to the said J. Donald Frances, hereinafter termed "Contractor", upon the following express terms and conditions:
- (1) That the Contractor will be permitted to erect and maintain a portable scaffold to be moved from time to time within the above described working space as the work requires, enclosing same with a suitable barricade and to protect pedestrians and cars from all harm or damage during the progress of the work.
- (2) That the Contractor shall place on the outside corners of any walkway, barricades or obstructions, red lights during all periods of darkness and provide lighting systems for all tunnels.
- (3) That the Contractor shall remove all fences, barricades, loose materials and other obstructions on the sidewalk and street immediately after the necessity for their existence on said sidewalk or street has ceased, such time to be determined by the City Manager, and in any event all such sidewalk, barricades, materials, equipment and other obstructions shall be removed not later than September 5, 1959.
- (4) That the City reserves the right to revoke at any time any and all the privileges herein granted or to require the erection or installation of additional barriers or safeguards if the conditions demand it.
- (5) That the Contractor shall furnish the City of Austin a surety bond in the sum of Two Thousand Dollars (\$2,000), which shall protect, indemnify and hold harmless the City of Austin from any claims or damages to any person or property that may accrue to or be brought by any person by reason of the exercise or abuse of the privileges granted the Contractor by the City of Austin and shall guarantee the replacement of all sidewalks, pavement and all other public property and public utilities disturbed or removed during the construction work and shall further guarantee the construction of a walkway and other safeguards during the occupancy of the space.

THENCE, following the durving west line of the said Lot 7, Block C of Ford Place No. 1 to the left an arc distance of 3.01 feet, the sub-chord of which arc bears N 30° 21' E 3.00 feet to the point of beginning.
