Regular Meeting

April 26, 1956
10:00 A.M.

Council Chamber, City Hall

The meeting was called to order with Mayor Miller presiding.

Councilman Long offered the following resolution and moved its adoption:

(RESOLUTION)

WHEREAS, there now exist Public Cab Stands on the South side of West 7th Street in the 100 Block, and on the North side of East 7th Street in the 100 Block; and,

WHEREAS, the Traffic Engineer of the City of Austin has found that passage of taxicabs from the former cab stand to the latter cab stand creates a serious and unnecessary hazard; Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

1. That the Public Cab Stand on the South side of West 7th Street, beginning at the West property line of Congress Avenue and extending Westerly 20 feet, be and the same is hereby eliminated.

2. That Public Cab Stand on the North side of West 7th Street, beginning at the West property line of Congress Avenue and extending Westerly 20 feet, capacity one taxicab, be and the same is hereby established subject to the rules and regulations prescribed by ordinance.

Pursuant to published notice thereof at 10:30 o'clock A.M. the Council held a public hearing on the paving of portions of Alegria Road, Arcadia Avenue, Madison Avenue and Ruth Avenue. MRS. JOHN MUS, Route 3, Box 314, inquired about the status of a paving lien. The City Attorney and City Manager explained this to her.

AN ORDINANCE CLOSING THE HEARING GIVEN TO THE REAL AND TRUE OWNERS OF PROPERTY ABUTTING UPON SUNDRY STREETS IN THE CITY OF AUSTIN, TEXAS, WITHIN THE LIMITS HEREINAFTER DEFINED, AS TO SPECIAL BENEFITS TO ACCRUE TO SAID PROPERTY AND THE REAL AND TRUE OWNERS THEREOF BY VIRTUE OF THE IMPROVEMENT OF SAID STREETS WITHIN SAID LIMITS, AND AS TO ANY ERRORS, INVALIDITIES OR

IRREGULARITIES IN ANY OF THE PROCEEDINGS OR CONTRACT THEREFOR; FINDING AND DETERMINING THAT EACH AND EVERY PARCEL OF PROPERTY ABUTTING UPON SAID STREETS WITHIN THE LIMITS DEFINED WILL BE SPECIALLY BENEFITED AND ENHANCED IN VALUE IN EXCESS OF THE AMOUNT OF THE COST OF SAID IMPROVEMENTS PROPOSED TO BE, AND AS, ASSESSED AGAINST SAID ABUTTING PROPERTY AND THE REAL AND TRUE OWNERS THEREOF, AND LEVYING AN ASSESSMENT FOR THE PAYMENT OF A PORTION OF THE COST OF IMPROVING SAID STREETS WITHIN THE LIMITS DEFINED, FIXING A CHARGE AND LIEN AGAINST ALL SAID ABUTTING PROPERTIES, AND THE REAL AND TRUE OWNERS THEREOF, PROVIDING FOR THE ISSUANCE OF ASSIGNABLE CERTIFICATES UPON THE COMPLETION AND ACCEPTANCE OF SAID WORK, THE MANNER AND TIME OF PAYMENT THEREOF, AND PROVIDING FOR THE MANNER AND METHOD OF COLLECTION OF SAID ASSESSMENTS AND CERTIFICATES; DECLARING AN EMERGENCY, AND PROVIDING THAT THIS ORDINANCE SHALL BECOME EFFECTIVE IMMEDIATELY UPON ITS PASSAGE.

The Council referred the request of MR. WILLIAM WEEG for a stop sign on 32nd Street at Fairfax, to the Traffic Engineer for study.

Action was deferred on the request of MR. GOODFRIEND to construct an overpass between the Maverick-Clark Building and the Goodfriend Building, for study.

Councilman Long presented a request from a Mrs. Wilson that while the contractor is putting in the sewer line up to the subdivision on Del Curto Road, that he make connections to property within 100' distances while the crew is working in the area. The Director of Water Utilities stated there was an arrangement with KARL WAGNER to make an extension on the line which he thought would cover this request; however he would check into this to see, and the matter was referred to him.

The City Manager submitted recommended fees for airport services. The Council went over the comparison of fees charged by other cities, and studied the recommendation, and asked the City Manager to bring in an ordinance next week to cover. MR. AMOS HEROLD took part in the discussion, stating the fees as recommended were not sufficient.


