

# WORKSESSION WEDNESDAY MAY 19, 1999

The following represents the actions taken by the Austin City Council in the order they occurred during the meeting. While the minutes are not in sequential order, all agenda items were discussed.

THE CITY COUNCIL OF AUSTIN, TEXAS, CONVENED AT 1:50 P.M., ON WEDNESDAY, MAY 19, 1999, AT TOWN LAKE CENTER, 721 BARTON SPRINGS ROAD, AUSTIN, TEXAS, FOR THE FOLLOWING PURPOSES:

Mayor Watson called the meeting to order, noting the absence of Council Member Spelman.

EXECUTIVE SESSION (No Public Discussion on These Items)
