



## **Austin City Council MINUTES**

**SPECIAL CALLED MEETING - 4:00 P.M.  
MARCH 3, 1993 - TOWN LAKE CENTER**

**Mayor Todd called to order the special called meeting of the Council Aviation Subcommittee, noting the absence of Councilmember Epstein.**

- 1. Approval of Minutes of February 10, 1993 Council Aviation Subcommittee Meeting**

**On Councilmember Reynolds' motion, Councilmember Garcia's second, 6-0 Vote, Councilmember Epstein absent.**

- 2. Review Public Information Program**

**Becky Gadell, Public Information Director, reported with slides. Council viewed a video showing what the proposed new airport at the Bergstrom Air Force Base proposal will be.**

**Aviation Director Charles Gates told Council there will be a public hearing on April 15, 1993 on the airport master plan.**

**Willie Lewis, Airport Advisory Committee, read the recommendation for airport bond referendum language, which includes the closing of Mueller Airport when the new airport opens, non-binding referendum language and the placing of the proposition on the ballot.**

**Suggestions were made concerning the wording on the ballot. City Manager Barnett suggested the wording be kept simple with only the information absolutely necessary. She said the expanded information can be dealt with in the publicity.**

**Mayor Todd said the Council suggestions will be looked by the bond counsel.**
