**CITY OF AUSTIN QUALIFICATIONS FOR
APPOINTMENT TO THE
TRAVIS COUNTY HOSPITAL DISTRICT BOARD OF MANAGERS**

Requirements

- Shall be a resident of the Travis County Hospital District service area.
- In addition to submission of standard Board application forms, shall complete and submit a Travis County Hospital District Financial Disclosure Form.
- As a goal, at least 75% of board members should be individuals with demonstrated expertise and qualifications involving finance, accounting, banking, legal affairs, government, health and/or social service management, and health care providers.
- Only 50% of the board's appointees may derive more than 25 percent of their income from the provision of health care services or from the health care industry.
- The Travis County Hospital District Board may include a member of the Federally Qualified Health Center Board.

Restrictions

- No employee, officer or board member of any entity that receives funds from the Travis County Hospital District shall be a member of the Board
- No employee, officer or board member of any hospital shall be a member of the Board.
- No employee of the Travis County Hospital District shall be a member of the Board.
- No attorney, CPA or other person who receives or whose employer receives in excess of 10% of its income from an entity that receives payment directly from the Travis County Hospital District shall be a member of the Board.
