


#### Abstract

AN ORDINANCE REZONING AND CHANGING THE ZONING MAP FOR THE PROPERTY LOCATED AT 639 WEST DITTMAR ROAD FROM SINGLE FAMILY RESIDENCE STANDARD LOT (SF-2) DISTRICT TO FAMILY RESIDENCE-CONDITIONAL OVERLAY (SF-3-CO) COMBINING DISTRICT.


## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. The zoning map established by Section 25-2-191 of the City Code is amended to change the base district from single family residence standard lot (SF-2) district to family residence-conditional overlay (SF-3-CO) combining district on the property described in Zoning Case No. C14-04-0142, on file at the Neighborhood Planning and Zoning Department, as follows:

Lot 5, T.Z. Evans Subdivision, a subdivision in the City of Austin, Travis County, Texas, according to the map or plat of record in Plat Book 48, Page 11, of the Plat Records of Travis County, Texas, SAVE AND EXCEPT a 0.33 acre tract of land, more or less, out of Lot 5, T.Z. Evans Subdivision, the tract of land being more particularly described by metes and bounds in Exhibit "A" incorporated into this ordinance, (the "Property")
locally known as 639 Dittmar Road, in the City of Austin, Travis County, Texas, and generally identified in the map attached as Exhibit "B".

PART 2. The Property within the boundaries of the conditional overlay combining district established by this ordinance is subject to the following conditions:

The maximum number of curb cuts on the Property that fronts Dittmar Road, is one.
Except as specifically restricted under this ordinance, the Property may be developed and used in accordance with the regulations established for the family residence (SF-3) base district and other applicable requirements of the City Code.

PART 3. This ordinance takes effect on , 2004.

## Field Notes for Parcel 17A

BEING 0.033 OF ONE ACRE ( 1,450 SF) OF LAND, MORE OR LESS, OUT OF AND A PART OF THE WILLIAM CANNON SURVEY NO 19 IN TRAVIS COUNTY, TEXAS, SAME BEING A PORTION OF LOT 5 OF THE T 2 . EVANS SUBDIVISION RECORDED IN BOOK 48, PAGE 11 OF THE PLAT RECORDS OF TRAVIS COUNTY, TEXAS, CONVEYED TO THOMAS 2 EVANS BY DEED FILED FOR RECORD ON MARCH 25, 1964 RECORDED IN VOLUME 274B, PAGE 330 OF THE REAL PROPERTY RECORDS OF TRAVIS COUNTY, TEXAS, SAID 0.033 OF ONE ACRE OF LAND BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS EOLLONS AND as Shown on the attached sketch

Beginning at a $5 / 8$ inch iron pin with tag set in the proposed south line of Dittmar Road, same being in the north line of Lot 5, $T \mathrm{Z}$. Evans Subdivision, recorded in Book 48, Page 11 of the Plat Records of Travis County, Texas, conveyed to Thomas 2. Evans by deed recorded in Volume 2748, page 330 of the Real property Records of Travis County, Texas, same also being North $78^{\circ} 13^{\prime} 26^{\prime \prime}$ East, a distance of 63.36 feet from the northwest corner of said Lot 5, for the Point of Beginning and the most westerly corner of the herein described tract of land and having grid coordinates, $N=1004022434$ and E=3098769.87;
(1) THENCE, North $78^{\circ} 13^{\prime} 26^{\prime \prime}$ East, a distance of 25.87 feet, with the existing south lIne of Dittmar Road and the north line of said Lot 5 , to a point at the most northerly corner of said lot 5 , for the most northerly corner of the herein described tract of land;
(2) THENCE, South $45^{\circ} 40^{\prime} 03^{\prime \prime}$ East, a distance of 7437 feet, with the existing south line of Dittmar Road and the northeasterly line of said lot 5 , to a point at the most easterly corner of said Lot 5 , same being the most northerly corner of hot 4 of said $T$. Z Evans Subdivision, for the most easterly corner of the herein described tract of land,
(3) THENCE, South $44^{\circ} 19^{\prime} 57^{\prime \prime}$ Gest, a distance of 1693 feet, with the southeasterly inline of said Lot 5 and the northwesterly lane of said Lot 4 to a $5 / 8$ inch iron pan with tag set in the proposed south line of Dittmar Road, for the most southerly corner of the herein described tract of land.
(4) THENCE, North $45^{\circ} 14^{\circ} 19^{\prime \prime}$ West, a distance of 12.90 . feet, with the proposed southwesterly line of Dittmar Road to a $5 / 8$ inch $2 r o n$ pin with tag set at the point of curvature of a circular curve to the left,
(5) THENCE, along sard curve to the left of 555.00 feet radius, an arc distance of 76.09 feet, having an angle of intersection of $07^{\circ} 51^{\prime} 20^{\prime \prime}$ (the long chord of said curve bears North $49^{\circ} 09^{\prime} 58^{\prime \prime}$ Yest, a distance of 76.03 feet), to the point of Beginning and containing an area of 0.033 of one acre of land, more or less.
