AN ORDINANCE WAIVING CERTAIN REQUIREMENTS IN CHAPTER 14-8 OF THE CODE, CERTAIN FEES AND CHARGES, AND AUTHORIZING PAYMENT OF CERTAIN COSTS FOR THE GREATER EAST AUSTIN YOUTH ASSOCIATION'S 2005 JUNETEENTH PARADE AND FESTIVAL TO BE HELD JUNE 18, 2005.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:
