

We, the undersigned owners of property affected by the requested zoning change described in the referenced file, do hereby protest against any change of the Land Development Code which would zone the property to any classification other than SF-3.

Reasons for protest:

1. Rezoning to anything but SF-3 at this location would go against what our neighbors across Oltorf, Bouldin Creek Neighborhood Association, have developed in their neighborhood plan regarding the placement of commercial nodes along places where our associations meet: South 1<sup>st</sup> and South 5<sup>st</sup>.

2. Galindo Neighborhood Association does not have a neighborhood plan at this time. Our neighborhood plan should be underway within the year and this will give all of our neighbors a chance to participate in the process of deciding what we would like to see happen in the neighborhood.

3. The proposed rezoning request will break up a purely residential block and set a

precedent for allowing further commercial rezoning.

4. Galindo Neighborhood Association voted unanimously in opposition to any rezoning changes along Oltorf at our association meeting on May 23<sup>rd</sup>.
