SUBJECT: Authorize execution of a 12-month supply agreement with BOUND TO STAY BOUND BOOKS, Jacksonville, IL, for pre-bound juvenile books for the Central Texas Library System in an amount not to exceed \$51,824.05, with two 12-month extension options in an amount not to exceed \$51,824.05 per extension option, for a total agreement amount not to exceed \$155,472.15.

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$34,549.37 is available in the Fiscal Year 2004-2005 Special Revenue Fund for the Library Department. Funding for the remaining four months of the original contract period and extension options is contingent upon available funding in future budgets.

FISCAL NOTE: There is no unanticipated fiscal impact. A fiscal note is not required.

MBE / WBE: This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

This contract will establish a supply agreement for pre-bound juvenile books for the 76 member libraries of the Central Texas Library System (CTLS). Pre-bound books are books that are purchased from the publisher unbound and then bound with covers designed for maximum durability for library use. The covers are illustrated with the original artwork from the publishers' dust jacket. Common examples are Hardy Boys and Nancy Drew mysteries.

The CTLS is a voluntary cooperative system comprised of 76 public libraries in a 30 county region. These libraries join together as specified in the Texas Library Systems Act to develop and improve public library services in Texas. The Austin Public Library, CTLS Division, has received State and Federal grants annually since 1972 for collection development for the member libraries. The CTLS Division administers these grant funds. Materials purchased with the grant funds are placed in the collections of the member libraries.
