**<u>PURCHASING:</u>** Low bid of two received.

MBE / WBE: 0.00% MBE and 30.12% WBE subcontractor participation.

This project will increase 38th Street's left turn lane capacity onto southbound Guadalupe Street by widening approximately 500 feet of the north side of 38th Street, east of Guadalupe Street.

The contract allows 40 calendar days for completion of this project.

Bid documents were distributed to 5 general contractors. Bids were opened on December 16, 2004. Aaron Concrete Contractors, LP submitted the lower of 2 bids received:

Aaron Concrete Contractors, LP, Austin, TX	\$266,136.40
Jay-Reese Contractors, Inc, Austin, TX	\$315,584.00

The contractor's choice of work methodology provides for 5 areas of subcontracting opportunities listed below. Participation subgoals stated in the solicitation were 13.86% MBE and 6.18% WBE. Total participation estimated on base bid amount of \$266,136.40.


