MBE / WBE: This contract was awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore no goals were established for this solicitation.

On September 30, 2004, Council approved the negotiation and execution of a contract with Hummingbird LTD, for the purchase of an enterprise document imaging and management system for the Office of the City Clerk and the Office of Vital Records-Health and Human Services Department in an amount not to exceed \$1,259,000. Subsequently, staff negotiated the contract amount to \$1,088,469.

Amendment No. 1 will provide for continuation of maintenance and support services for 12 months after March 31, 2005, with four 12-month extension options for the document imaging and management software from Hummingbird Ltd.

The contract negotiated with the vendor included a warranty for 180 days after final acceptance of the software by the City. During this period, if the software did not operate in compliance with all material respects to the representations made by the vendor in its proposal or did not conform to the requirements of the RFP, the vendor agreed to correct any programming errors and make the necessary modifications, additions or adjustments to the software without any charge to the City.
